**Board Meeting
June 15, 2017**

PRESIDENT'S REPORT

Jimmy Isenberg thanked the Board members and staff for their support during his term as President.

FINANCIAL OFFICER'S REPORT

The Financial Officer's Report was presented. The Board accepted the Report and the following action was taken:

- Accepted the recommended 2017 – 2018 awards for the Nursing Incentive Scholarship Fund.

EXECUTIVE DIRECTOR'S REPORT

The written Report of the Executive Director was presented and included information on Administrative News; Customer Satisfaction Survey; HB 304; KBN Licensee Data to KCEWS; 2015 – 2018 KBN Strategic Plan; Legal Update; Upcoming Meetings; Agreed Orders, Consent Decrees, Investigation and Compliance Reports; and Sex Offender Registry. The Report was accepted as written.

EDUCATION COMMITTEE

The May 18, 2017 Education Committee Meeting Report was presented. The Board accepted the Report and the following actions were taken:

Hazard Community & Technical College, Lees Campus, Jackson, KY

- Accepted the proposal dated April 17, 2017, to establish a Practical Nursing Program at the Hazard Community & Technical College, Lees Campus, Jackson, KY; and
- Granted developmental approval status for Hazard Community & Technical College Practical Nursing Program, Lees Campus, Jackson, KY.

Campbellsville University, Campbellsville, KY – ADN Document Review Site Visit

- Accepted the document review site visit report dated March 28, 2017, Campbellsville University Associate Degree Nursing Program, Campbellsville, KY, and approved the following requirements:
 1. Establish written criteria for the evaluation of clinical facilities and ensure that the criteria is utilized by the Program of Nursing in accordance with 201 KAR 20:260 Section 2(3)(h)2 and 2(3)(s); and
 2. Ensure that recruitment materials provide accurate and complete information to prospective students about the current cost of the program as specified in 201 KAR 20:260 Section 2(3)(q)3.
- The Program of Nursing shall submit a report addressing the requirements to be met to the Kentucky Board of Nursing Education Consultant on or before August 4, 2017.

- Granted continuing approval of Campbellsville University Associate Degree Nursing Program, Campbellsville, KY.

Somerset Community College, Somerset, KY – PN Programs Document Review Site Visit

- Accepted the document review site visit Report dated April 18 and 19, 2017, Somerset Community College Associate Degree Nursing Program, Somerset, KY, and approved the following requirements:
 1. Ensure nurse faculty at the main and non-main campuses are sufficient in number and expertise to accomplish program outcomes and quality improvement and to implement the curriculum as determined by program outcomes, course objectives, the level of the students, the number of students and classes admitted annually, and the educational technology utilized in accordance with 201 KAR 20:260 Section 2(7) and KAR 20:310 Section 2(1)(a)2;
 2. Ensure that the assistant program administrators at non-main campuses have twenty-five percent release time for administrative duties as specified in 201 KAR 20:260 Section 4(2)(b);
 3. Establish at the main and non-main campuses, a written policy and provide opportunities for student participation in program development, implementation, governance and evaluation as stipulated in 201 KAR 20:340 Section 1(3) and Section 3(3)(k); and
 4. Ensure that the Somerset and London campuses technology is available and adequate for students and faculty, on a consistent basis, to enhance student learning and to meet outcomes of the program in accordance with 201 KAR 20:350 Section 3(4).
- Approval granted to the Program of Nursing, to submit a report addressing the requirements to the Kentucky Board of Nursing Education Consultant on or before August 4, 2017; and
- Granted the continuing approval of Somerset Community College Practical Nursing Programs, Somerset, KY, London, KY, and Albany, KY.

Kentucky State University, Frankfort, KY, Curriculum Change – Generic BSN

- Accepted the proposed curriculum revisions dated April 28, 2017, by Shiphrah Williams-Evans, PHD, Dean of Nursing, Kentucky State University Baccalaureate Degree Nursing Program, Frankfort, KY.

PRACTICE COMMITTEE

- Approved the revisions to 201 KAR 20:400, delegation of nursing tasks; and
- Accepted the Advisory Opinion Statement #36 – role of nurses in resuscitation.

ADVANCED PRACTICE REGISTERED NURSE COUNCIL

The May 24, 2017 Advanced Practice Registered Nurse Council Meeting Report was presented. The Board accepted the Report and the following actions were taken:

- Approved the revision to Advanced Practice Registered Nurse Council Scope and Functions;
- Approved the Advisory Opinion on the Scope of Practice of the Advanced Practice Registered Nurse in the performance of Diagnostic and Therapeutic Bronchoscopy;
- Approved the Advisory Opinion on the Scope of Practice of the Advanced Practice Registered Nurse in performance of Hormone Pellet Placement;
- Approved development of an administrative regulation for Advanced Practice Registered Nurse prescribing of Buprenorphine for medication assisted treatment; and
- Accepted the APRN council member nominations.
