2 Board of Nursing

3 (Amendment)

4 201 KAR 20:070. Licensure by examination.

5 RELATES TO: KRS 194A.540, 314.041, 314.051(3), (6), 314.103, 314.109, 314.475

6 STATUTORY AUTHORITY: KRS 314.041(2), 314.051(3), 314.103, 314.131(1)

7 NECESSITY, FUNCTION, AND CONFORMITY: KRS 314.131(1) authorizes the Kentucky Board of
8 Nursing to promulgate administrative regulations to implement the provisions of KRS 314.011
9 to 314.991. KRS 314.041(2) requires an applicant for licensure as a registered nurse to pass an
10 examination prescribed by the board. KRS 314.103 authorizes the board to require a criminal
11 background check investigation of an applicant or nurse. KRS 314.051(3) requires an applicant
12 for licensure as a licensed practical nurse to pass an examination prescribed by the board. This
13 administrative regulation establishes the requirements for the licensure of nurses by
14 examination.

15 Section 1. Eligibility for Licensure by Examination for a Graduate of a Kentucky Program or
16 Other State or Territorial Nursing Program.

17 (1) To be eligible for licensure by examination, an applicant shall:

18 (a) Submit:

19 1. A properly executed application for licensure, as required by and incorporated by
20 reference in 201 KAR 20:370, Section 1(1);

- 1 2. The licensure application fee as established in 201 KAR 20:240;
- 2 3. A criminal record check completed within six (6) months of the date of the application by
- 3 the Department of Kentucky State Police (KSP) and the Federal Bureau of Investigation (FBI)
- 4 using the FBI Applicant Fingerprint Card, and including payment of any required fee to the KSP
- 5 and the FBI;
- 6 4. A certified or attested copy of the court record of any misdemeanor or felony conviction
- 7 as required by 201 KAR 20:370, Section 1(3);
- 8 5. A letter of explanation that addresses each conviction, if applicable;
- 9 6. A certified copy of any disciplinary action taken on any professional or business license in
- 10 another jurisdiction with a letter of explanation or a report if there is any disciplinary action
- 11 pending on any professional or business license in another jurisdiction; and
- 12 7. Evidence of completion of the jurisprudence examination required by KRS 314.041(4) for
- 13 RN applications or KRS 314.051(4) for LPN applications;
- 14 (b) Notify the board as soon as a new address is established after submitting the application;
- 15 (c) Submit a copy of a marriage certificate, divorce decree, Social Security card, or court
- 16 order to change the applicant's name, if the applicant's name is changed after the original
- 17 application is filed;
- 18 (d) While taking the examination, abide by and cooperate with security procedures adopted
- 19 by the board; and
- 20 (e) Apply to take and pass the National Council Licensure Examination.

1 (2) An application for licensure shall be valid for a period of one (1) year from the date the
2 application is filed with the board office or until the board receives the results of the
3 examination.

4 (3)(a) Except as provided in paragraph (b) of this subsection, the name of the applicant shall
5 appear on the Certified List of Kentucky Program of Nursing Graduates or the Certified List of
6 Out-of-state Program of Nursing Graduates.

7 (b) If the name does not appear on the list, the applicant shall request that the program
8 submit to the board an official transcript verifying completion of program requirements.

9 (c) The Certified List of Out-of-state Program of Nursing Graduates shall be submitted by the
10 nurse administrator of the out-of-state program of nursing.

11 (4)(a) The applicant shall complete the three (3) hour continuing education course on
12 domestic violence within three (3) years of licensure as required by KRS 194A.540.

13 (b) The applicant shall complete the applicable [~~one and one-half (1.5) contact hour~~]
14 continuing education courses [on pediatric abusive head trauma within three (3) years of
15 ~~licensure]~~ as required by 201 KAR 20:215, Section 5.

16 (5) An applicant shall not be licensed until a report is received from the FBI pursuant to the
17 request submitted pursuant to subsection (1)(a)3 of this section and any conviction is
18 addressed by the board.

19 (6) A graduate of a school of nursing in Puerto Rico after September 1, 2006, in addition to
20 the other requirements of this section, shall provide evidence of evaluation of the graduate's
21 transcript by the Commission on Graduates of Foreign Nursing Schools or a credential
22 evaluation organization that is a member of the National Association of Credentialing

1 Evaluation Services. The evaluation shall indicate that the school of nursing is substantially
2 equivalent to a school of nursing in this state.

3 Section 2. Retaking the Examination. (1) An examination candidate who fails to achieve a
4 passing result may retake the examination after meeting the requirements of Section 1 of this
5 administrative regulation.

6 (2) The applicant shall not be eligible to take the examination more often than once every
7 forty-five (45) days.

8 Section 3. Release of Examination Results. The board shall release examination results to:

9 (1) The candidate;

10 (2) Other state boards of nursing;

11 (3) The National Council of State Boards of Nursing, Inc.;

12 (4) The candidate's program of nursing; and

13 (5) An individual or agency who submits an applicant's or licensee's written authorization for
14 their release, if applicable.

15 Section 4. Provisional License. (1) An applicant shall request a provisional license by
16 completing the application for licensure required by Section 1 of this administrative regulation.

17 (2)(a) The board shall issue the provisional license to the applicant after Section 1(1)(a) and
18 (3) of this administrative regulation are met, but not until the report is received from the FBI
19 and any conviction is addressed by the board.

20 (b) In this case of a graduate of a foreign nursing school, the board shall issue the provisional
21 license after the requirements of 201 KAR 20:480[~~Section 1(1) and (4)~~] are met.

1 (3) To qualify as direct supervision pursuant to KRS 314.041(5) and KRS 314.051(6), the nurse
2 responsible for the applicant shall be physically present in the facility and immediately available
3 to the applicant during work hours while the applicant holds a provisional license.

4 (4) The nurse responsible for the applicant shall be currently licensed or privileged to
5 practice pursuant to KRS 314.475 as a nurse in Kentucky.

6 (5) Upon notification to the board that the applicant has failed the NCLEX examination after
7 two (2) attempts, the provisional license shall be voided.

8 (6) A provisional license shall be valid for a period not to exceed six (6) months.

9 Section 5. (1) An applicant not from a party state under the Nurse Licensure Compact who is
10 issued a license and who does not have permanent residency in Kentucky shall be issued a
11 license that indicates on the license that it is only valid in Kentucky.

12 (2) The board may request that an applicant provide evidence of the applicant's state of
13 residence.

A public hearing on this administrative regulation shall be held on Thursday, June 23, 2022, at 10:00 a.m. (EDT) in the office of the Kentucky Board of Nursing, 312 Whittington Parkway, Suite 300, Louisville, Kentucky. (1) Provide a brief summary of:

(a) What this administrative regulation does: This administrative regulation establishes the requirements to obtain an RN or LPN license by examination.

(b) The necessity of this administrative regulation: This administrative regulation is necessary because of KRS 314.041 and KRS 314.051.

(c) How this administrative regulation conforms to the content of the authorizing statutes: of KRS 314.041 and KRS 314.051, which requires the Board to promulgate an administrative regulation concerning obtaining an RN or LPN license.

(d) How this administrative regulation currently assists or will assist in the effective administration of the statutes: This administrative regulation assists in the effective administration of the statutes by setting the standards and process for obtaining an RN or LPN license.

(2) If this is an amendment to an existing administrative regulation, provide a brief summary of:

(a) How the amendment will change the existing administrative regulation: The amendment includes recent educational requirements under 201 KAR 20:215; expands requirements for graduates of foreign programs of nursing to include passing a English proficiency exam under 201 KAR 20:480 before they are issued a provisional license. Provides that graduates of nursing programs may take two attempts to pass the National Council Licensure Examination (NCLEX) before their provisional license is voided; and it limits provisional licenses to be valid for a period of six months.

(b) The necessity of the amendment to the administrative regulation: To address changes to existing regulations, and to address the nursing shortage by allowing new graduates to stay in the workforce if they fail their first attempt at passing the NCLEX.

(c) How the amendment conforms to the content of the authorizing statutes: The Board is authorized to make these changes

(d) How the amendment to the administrative regulation will assist in the effective administration of the statutes: By clearing up inconsistencies in current regulations.

(3) List the type and number of individuals, businesses, organizations, or state and local governments affected by this administrative regulation: Applicants for nursing licensure, number unknown.

(4) Provide an analysis of how the entities referenced in question (3) will be impacted by either the implementation of this administrative regulation, if new, or by the change if it is an amendment, including:

(a) A detailed explanation of the actions the entities referenced in question (3) will be required to undertake in order to comply with this proposed administrative regulation: Nurses of foreign programs of nursing will be required to pass an English proficiency exam before given a provisional license. All graduates of nursing programs will need to pass the NCLEX after a second attempt within 6 months.

(b) An estimate of the costs imposed on entities referenced in question (3) in order to comply with this proposed administrative regulation: There is no additional cost.

(c) The benefits that may accrue to the entities referenced in question (3) as a result of compliance: Applicants will be allowed two attempts at the NCLEX to keep their provisional licenses.

(5) Provide an estimate of how much it will cost the administrative body to implement this administrative regulation:

(a) Initially: No additional costs.

(b) On a continuing basis: None.

(6) Provide the source of the funding to be used for the implementation and enforcement of this administrative regulation: Agency funds.

(7) Provide an assessment of whether an increase in fees or funding will be necessary to implement this administrative regulation or amendment: No increase is needed.

(8) State whether or not this administrative regulation establishes any fees or directly or indirectly increases any fees: It does not.
