4 201 KAR 20:260. Organization and administration standards for prelicensure registered nurse or  
5 practical nurse programs of nursing.

6 RELATES TO: KRS 314.041(1), 314.111(1), 314.111(5), 314.131

7 STATUTORY AUTHORITY: KRS 314.111(1), 314.131(1), (2)

8 NECESSITY, FUNCTION, AND CONFORMITY: KRS 314.111(1) and 314.131(2) require the board  
9 to approve schools of nursing and courses preparing persons for licensure and to monitor  
10 standards for nurse competency under KRS Chapter 314. KRS 314.131(1) authorizes the board to  
11 promulgate administrative regulations to implement KRS Chapter 314. This administrative  
12 regulation establishes the organization and administration standards for prelicensure registered  
13 nurse or practical nurse programs.

14 Section 1. Definitions.

15 (1) "Campus" means a division of a college or university that has its own grounds, buildings,  
16 and students, but is administratively joined to the rest of the college or university.

17 (2) "Clerical assistance" means the provision of administrative, secretarial, or clerical help by  
18 qualified individuals that assists the program of nursing.

19 (3) "Clinical instructor" means a nurse who is employed by a program of nursing solely to  
20 provide students with traditional clinical or simulated experiences.

1 (4) "Nurse faculty" means a nurse who is employed by a program of nursing, either full-time,  
2 part-time, or adjunct, to provide didactic instruction, and may also provide clinical instruction or  
3 simulated experiences.

4 (5) "Preceptor" means a nurse with demonstrated competence in a specific clinical area who  
5 serves as a role model and mentor to assist in the development and validation of the  
6 competencies of a student.

7 (6) "Program of nursing" means the educational unit that prepares a person for licensure as a  
8 registered or licensed practical nurse.

9 (7) "Nursing track" means a path within a program of nursing that leads to licensure as a nurse.

10 Section 2. Organization or Administration Standards for Prelicensure Registered Nurse and  
11 Practical Nurse Programs. To be eligible for approval by the board, a program shall have:

12 (1) A governing institution. (a) The governing institution that establishes and conducts the  
13 program of nursing shall hold accreditation as a postsecondary institution, college, or university  
14 by an accrediting body recognized by the U.S. Department of Education.

15 (b) The governing institution shall assume full legal responsibility for the overall conduct of  
16 the program of nursing. The program of nursing shall have comparable status with the other  
17 programs in the governing institution and the relationship shall be clearly delineated.

18 (c) The governing institution shall:

19 1. Designate a program administrator for the prelicensure program of nursing who is qualified  
20 pursuant to 201 KAR 20:310 and is responsible for fulfilling the duties specified in subsection (3)  
21 of this section on a twelve (12) month basis;

- 1        2. Assure that at least fifty (50) percent of the program administrator's time shall be dedicated  
2 to complete the duties specified in this administrative regulation at each program of nursing. A  
3 governing institution that is unable to comply with this standard may request an exemption from  
4 the board in writing.
- 5        a. The request shall state the reasons for noncompliance and the efforts the institution has  
6 taken and will take to comply with the standard.
- 7        b. If the exemption is granted, it shall be for twelve (12) months from the date of board  
8 approval. During this time, the governing institution shall not open a new program of nursing and  
9 shall not increase enrollment at an existing program of nursing;
- 10       3. Provide evidence that the fiscal, human, physical, clinical, and technical learning resources  
11 shall be adequate to support program mission, processes, security, and outcomes;
- 12       4. Provide student support programs, services, and activities consistent with the mission of  
13 the governing institution that promote student learning and enhance the development of the  
14 student;
- 15       5. Make financial resources available to the program of nursing consistent with equivalent  
16 programs at the governing institution;
- 17       6. Employ nurse faculty pursuant to 201 KAR 20:310 in sufficient number and expertise to  
18 accomplish program outcomes and quality improvement;
- 19       7. Provide written policies for faculty related to qualifications for the position, rights and  
20 responsibilities of the position, criteria for evaluation of performance, workload, and retention;
- 21       8. Involve the nurse faculty in determining academic policies and practices for the program of  
22 nursing; and

1 9. Provide for the security, confidentiality, and integrity of faculty employment and student  
2 records.

3 (d) The governing institution shall provide an organizational chart that describes the  
4 organization of the program of nursing and its relationship to the governing institution;

5 (2) Administrative policies. (a) There shall be written administrative policies for the program  
6 of nursing that shall be:

7 1. In accord with those of the governing institution; and

8 2. Available to the board for review.

9 (b) The board shall be notified in writing of a change, vacancy, or pending vacancy, in the  
10 position of the program administrator within thirty (30) days of the program of nursing's  
11 awareness of the change, vacancy, or pending vacancy.

12 1. The head of the governing institution shall submit to the board in writing the name of the  
13 registered nurse who has been designated to assume the administrative duties for the program,  
14 the date the person will assume the duties of program administrator, and a copy of his or her  
15 curriculum vitae.

16 2. a. If there is to be a lapse between the date of the change or vacancy and the date the  
17 newly-appointed program administrator assumes duties, the head of the governing institution  
18 shall submit a plan of transition to ensure the continuity of the program.

19 b. Progress reports shall be submitted if requested by the board.

20 3. a. The length of the appointment of an interim program administrator shall not exceed six  
21 (6) months.

1       **b. Additional six (6) month periods may be granted upon request to the board based on a**  
2       **documented inability to fill the position.**

3       **(c) A written plan for the orientation of the nurse faculty to the governing institution and to**  
4       **the program shall be implemented.**

5       **(d) There shall be a written contract between the governing institution and each agency or**  
6       **institution that provides a learning experience for a student. A contract shall not be required for**  
7       **an observational experience.**

8       **1. The contract shall clearly identify the responsibilities and privileges of both parties.**

9       **2. The contract shall bear the signature of the administrative authorities of each organization.**

10      **3. The contract shall vest in the nurse faculty control of the student learning experiences**  
11      **subject to policies of the contractual parties.**

12      **4. The contract shall be current and may include an annual automatic renewal clause.**

13      **5. The contract shall contain a termination clause by either party;**

14      **(3) A program or an interim program administrator who shall have authority and responsibility**  
15      **in the following areas:**

16      **(a) Development and maintenance of collaborative relationships with the administration of**  
17      **the institution, other divisions or departments within the institution, related facilities, and the**  
18      **community;**

19      **(b) Participation in the preparation and management of the program of nursing budget;**

20      **(c) Screening and recommendation of candidates for nurse faculty appointment, retention,**  
21      **and promotion;**

- 1 (d) Submission of the qualifications of all nurse faculty and clinical instructors as set forth in  
2 201 KAR 20:310, Section 4;
- 3 (e) To provide leadership within the nurse faculty for the development, implementation, and  
4 evaluation of the program of nursing and program outcomes;
- 5 (f) To facilitate the implementation of written program policies for the following:
- 6 1. Student admission;
  - 7 2. Student readmission and advance standing;
  - 8 3. Student progression, which shall include:
    - 9 a. The level of achievement a student shall maintain in order to remain in the program or to  
10 progress from one (1) level to another; and
    - 11 b. Requirements for satisfactory completion of each course in the nursing curriculum.
  - 12 4. Requirements for completion of the program;
  - 13 5. Delineation of responsibility for student safety in health related incidents both on campus  
14 and at any clinical activity required by the program of nursing;
  - 15 6. Availability of student guidance and counseling services;
  - 16 7. The process for the filing of grievances and appeals by students;
  - 17 8. Periodic evaluation by the nurse faculty of each nursing student's progress in each course  
18 and in the program;
  - 19 9. Student conduct that incorporates the standards of safe nursing care; and
  - 20 10. Publication and access to current academic calendars and class schedules;
- 21 (g) To facilitate the continuing academic and professional development for the nurse faculty;

- 1 (h) 1. To initiate and coordinate the development of contracts with clinical facilities, the  
2 number and variety of which shall be adequate to meet curricular outcomes;
- 3 2. To develop written criteria for the selection and evaluation of clinical facilities and ensure  
4 that the criteria shall be utilized by the program of nursing; and
- 5 3. To assure that clinical facilities show evidence of approval by the appropriate accreditation,  
6 evaluation, or licensure bodies, if applicable;
- 7 (i) The establishment of student-nurse faculty ratio in the clinical practice experience.
- 8 1. The maximum ratio of nurse faculty to students in the clinical area of patients-clients shall  
9 be defensible in light of safety, learning objectives, student level, and patient acuity.
- 10 2. The student-nurse faculty ratio shall not exceed ten (10) to one (1) in the clinical practice  
11 experience, including observational or other supervised learning experiences.
- 12 3. This ratio shall not apply to on campus skill lab experiences;
- 13 (j) The submission of the Certified List of Kentucky Program of Nursing Graduates, as  
14 incorporated by reference in 201 KAR 20:070, upon student completion of all requirements for a  
15 degree, diploma, or certificate, regardless of the state in which the graduate intends to seek  
16 licensure;
- 17 (k) The development and maintenance of an environment conducive to the teaching and  
18 learning process;
- 19 (l) To facilitate the development of long-range goals and objectives for the nursing program;
- 20 (m) To ensure that equipment, furnishings, and supplies be current and replaced in a timely  
21 manner;

1 (n) To ensure that the nurse faculty has sufficient time to accomplish those activities related  
2 to the teaching-learning process and program outcomes;

3 (o) To coordinate an orientation to the roles and responsibilities of full-time, part-time,  
4 adjunct nurse faculty, and clinical instructors to the program of nursing and, as appropriate, to  
5 clinical facilities so that the mission, goals, and expected outcomes of the program shall be  
6 achieved;

7 (p) To facilitate regular communication with the full and part time nurse faculty and clinical  
8 instructors in the planning, implementation, and evaluation of the program of nursing;

9 (q) To ensure that recruitment materials provide accurate and complete information to  
10 prospective students about the program including the:

11 1. Admission criteria;

12 2. Program description, including course sequence, prerequisites, and corequisites;

13 3. Length of the program;

14 4. Current cost of the program, including tuition and all associated fees and expenses; and

15 5. Transferability of credits to other public and private institutions in Kentucky;

16 (r) To conduct or participate in the written evaluation of each nurse faculty member, clinical  
17 instructor, and program of nursing support staff according to published criteria, regardless of  
18 contractual or tenured status;

19 (s) To ensure the adherence to the written criteria for the selection and evaluation of clinical  
20 facilities utilized by the program of nursing;

21 (t) To maintain current knowledge of requirements pertaining to the program of nursing and  
22 licensure as established in 201 KAR Chapter 20;



1 (u) To attend the next available board orientation for program administrators but not later  
2 than within six (6) months of appointment;

3 (v) To develop a structure to allow nurse faculty to assist in the governance of the program;

4 (w) To ensure that the curriculum is developed and implemented pursuant to 201 KAR 20:320;

5 and

6 (x) To ensure that the program of nursing posts a link provided by the board to the information  
7 published by the board pursuant to 201 KAR 20:360, Section 5(4) on its Web site and refers all  
8 individuals seeking information about the program to this link.

9 (4) A system of official records and reports essential to the operation of the program of nursing  
10 maintained according to institutional policy. Provisions shall be made for the security and  
11 protection of records against loss and unauthorized distribution or use. The system shall include  
12 records of:

13 (a) Currently enrolled students to include admission materials, courses taken, grades received,  
14 scores for standardized tests, and clinical performance records;

15 (b) Minutes of faculty and committee meetings, which shall be maintained a minimum of five  
16 (5) years, irrespective of institutional policy;

17 (c) Faculty records including:

18 1. Validation of current licensure or privilege to practice as a Registered Nurse in Kentucky;

19 2. Evidence of fulfilling the faculty orientation requirements established in 201 KAR 20:310,  
20 Section 3(5); and

21 3. Performance evaluation for faculty employed more than one (1) year;

22 (d) Systematic plan of evaluation;

- 1 (e) Graduates of the program of nursing; and
- 2 (f) Administrative records and reports from accrediting agencies; and
- 3 (5) Official publications of the governing institution including:
- 4 (a) A description of the governing institution and program of nursing;
- 5 (b) Policies on admission, progression, dismissal, graduation, and student grievance
- 6 procedures; and
- 7 (c) A description of student services;
- 8 (6) Clerical assistance and support staff.
- 9 (a) There shall be clerical assistance and support staff sufficient to meet the needs of the
- 10 nursing program for the administrator, faculty, and students.
- 11 (b) Each campus shall have at least one (1) dedicated clerical staff.
- 12 (c) If the program of nursing does not have at least one (1) dedicated clerical staff, the program
- 13 administrator shall provide written justification to the board. The board shall evaluate the
- 14 justification to determine whether the program may operate effectively without dedicated staff
- 15 sufficient to meet the needs of the nursing program. If the board rejects the justification, the
- 16 program of nursing shall comply with the board's determination on clerical staffing.
- 17 (7) Nurse faculty, full-time, and part-time, with the authority and responsibility to:
- 18 (a) Plan, implement, evaluate, and update the program;
- 19 (b) Assist in the design, implementation, evaluation, and updating of the curriculum using a
- 20 written plan;

- 1 (c) Participate in the development, implementation, evaluation, and updating of policies for  
2 student admission, progression, and graduation in keeping with the policies of the governing  
3 institution;
- 4 (d) Participate in academic advisement and guidance of students;
- 5 (e) Provide theoretical instruction and clinical learning experiences;
- 6 (f) Evaluate student achievement of curricular outcomes related to nursing knowledge and  
7 practice;
- 8 (g) Develop and implement student evaluation methods and tools for each course that  
9 measure the progression of the student's cognitive, affective, and psychomotor achievement of  
10 course and clinical outcomes based on published rubrics and sound rationale;
- 11 (h) Participate in academic and professional level activities that maintain the faculty member's  
12 competency and professional expertise in the area of teaching responsibility;
- 13 (i) Communicate clinical outcomes to the student, clinical instructor, preceptor, and staff at  
14 the clinical site;
- 15 (j) Assume responsibility for utilizing the criteria in the selection of clinical sites and in the  
16 evaluation of clinical experiences on a regular basis;
- 17 (k) Evaluate the student's experience, achievement, and progress in relation to course and  
18 clinical outcomes, with input from the clinical instructor and preceptor, if applicable; and
- 19 (l) Delegate to a nurse employed by a clinical agency the supervision of a student performing  
20 a procedure; and
- 21 (8) Clinical instructors with the authority and responsibility to:

1 (a) Design, at the direction of the nurse faculty member, the student's clinical experience to  
2 achieve the stated outcomes of the nursing course in which the student is enrolled;

3 (b) Clarify with the nurse faculty member:

4 1. The role of the preceptor, if applicable;

5 2. The course responsibilities;

6 3. The course or clinical outcomes;

7 4. A course evaluation tool; and

8 5. Situations in which collaboration and consultation shall be needed;

9 (c) Participate in the evaluation of the student's performance by providing information to the  
10 nurse faculty member and the student regarding the student's achievement of established  
11 outcomes; and

12 (d) Delegate to a nurse employed by a clinical agency the supervision of a student performing  
13 a procedure.

14 3. Number of Students Enrolled [~~Notification of Change in Enrollment~~].

15 (1) All programs of nursing shall have on record with the board the [~~maximum~~] number of new  
16 students that the program is able to enroll in one (1) academic year. [~~This number shall be~~  
17 ~~referred to as the program's enrollment baseline.~~]

18 (2) There shall be no limit on the number of students who may attend a program of nursing if  
19 the program of nursing meets:

20 (a) the requirements of KRS 314.111(5); and

21 (b) the benchmarks set out in 201 KAR 20:360, Section 5(2)(f). [~~a) A program of nursing that~~  
22 ~~desires to increase its enrollment beyond its enrollment baseline shall submit a request to the~~

1 board. The request shall be sent in writing at least two (2) months prior to the date for which the  
2 requested increase is being sought. Exceptions to this time frame shall only be made for exigent  
3 circumstances. The request is only necessary if the increase is greater than the following:

- 4 1. If the enrollment baseline is fifty (50) or less, an increase of ten (10) students;
- 5 2. If the enrollment baseline is fifty one (51) 100, an increase of twenty (20) students; or
- 6 3. If the enrollment baseline is greater than 100, an increase of twenty five (25) students.

7 ~~(b) The request shall demonstrate that the program has sufficient resources to fulfill the~~  
8 ~~standards established by this administrative regulation for the anticipated increase in~~  
9 ~~enrollment. These sufficient resources shall include adequate:~~

- 10 1. Number of qualified faculty;
- 11 2. Classroom space;
- 12 3. Clinical sites;
- 13 4. Clerical support; and
- 14 5. Financial support.

15 ~~(c) The program shall investigate the projected impact of the increase on the operation of~~  
16 ~~programs of nursing within a fifty (50) mile radius and shall submit a report to the board.~~

17 ~~(d) The program of nursing shall submit evidence that it has met the benchmarks set out in~~  
18 ~~201 KAR 20:360, Section 5(2)(f).]~~

19 (3)(a) A program of nursing that meets the requirements set out in subsection (2) of this  
20 section may increase its enrollment without limitation.

21 (b) A program of nursing shall report any increase in enrollment to the board.

1 ~~[(a) The request shall be reviewed by board staff. Board staff may approve the request if it is~~  
2 ~~determined that the criteria listed in subsection (2) of this section have been met.~~

3 ~~(b) If board staff determines that the criteria listed in subsection (2) of this section have not~~  
4 ~~been met, the request shall be referred to the board for further consideration and a decision.]~~

5 (4)(a) The board may impose a limit on the number of students attending a program of nursing  
6 that does not meet the requirements of subsection (2) of this section.

7 (b) The board may deny an increase in enrollment for a program of nursing that does not meet  
8 the requirements of subsection (2) of this section.

9 Section 4. Multiple Campuses. (1)(a) A governing institution may have programs of nursing  
10 located on different campuses.

11 (b) Each campus shall be considered a separate program of nursing.

12 (2)(a) The governing institution shall designate a main campus headed by a program  
13 administrator.

14 (b) The program administrator shall have final responsibility and authority for the non-main  
15 campuses, but shall designate an assistant program administrator to assist in the governance of  
16 each non-main location. The assistant program administrator shall meet the qualification for a  
17 nurse faculty as set out in 201 KAR 20:310. The program administrator may designate the amount  
18 of release time for the assistant program administrator for administrative duties, but it shall not  
19 be less than twenty-five (25) percent.

20 (3) For purposes of calculating benchmarks set out in 201 KAR 20:360, Section 5(2)(f), each  
21 campus shall individually report its data annually to the board. The board shall evaluate the  
22 benchmarks for each campus individually.

1        (4) A governing institution that has extended its main campus to a new campus during the  
2        period 201 KAR 20:260E was in effect, from January 11, 2022 to October 8, 2022, shall take the  
3        necessary steps to comply with 201 KAR 20:280. The process shall begin within thirty (30) days  
4        of the effective date of this administrative regulation.

5        Section 5. Suspension of Enrollment. (1) A governing institution that decides to suspend  
6        enrollment in the program of nursing shall notify the board in writing within thirty (30) days  
7        following the decision. No longer enrolling in one (1) of several nursing tracks within a program  
8        of nursing shall not constitute suspension of enrollment for purposes of this administrative  
9        regulation.

10       (2) The notification shall identify the reasons leading to the decision and how long it is  
11       anticipated that the suspension will be in effect.

12       (3) The governing institution shall report to the board annually on the status of the suspension.

13       (4)(a) If the decision to reinstate enrollment is made within three (3) years of the decision to  
14       suspend enrollment, the governing institution shall notify the board in writing of the decision  
15       within thirty (30) days.

16       (b) The notification shall state the date classes will begin. It shall also list the faculty and clinical  
17       sites that will be utilized.

18       (5) If the decision to reinstate enrollment is made three (3) years or more from the decision  
19       to suspend enrollment, the governing institution shall comply with the procedures outlined in  
20       201 KAR 20:280.

21       Section 6. Change in Accreditation.

1 (1) A governing institution that seeks to change the U.S. Department of Education recognized  
2 accrediting body from which it receives accreditation shall notify the board when it has filed an  
3 application for accreditation.

4 (2) A governing institution with an application in process before the accrediting body shall be  
5 considered in compliance with Section 2(1)(a) of this administrative regulation.

6 (3)(a) A governing institution whose application has been denied by its accrediting body shall  
7 not be considered to be in compliance with Section 2(1)(a) of this administrative regulation.


8 (b) The board shall begin the process established in 201 KAR 20:360, Section 7 for withdrawal  
9 of approval.

  - (a) What this administrative regulation does: It sets standards for prelicensure RN and LPN programs of nursing.
  - (b) The necessity of this administrative regulation: It is required by statute.
  - (c) How this administrative regulation conforms to the content of the authorizing statutes: By setting standards.
  - (d) How this administrative regulation currently assists or will assist in the effective administration of the statutes: By setting standards.
  
- (2) If this is an amendment to an existing administrative regulation, provide a brief summary of:
  - (a) How the amendment will change this existing administrative regulation: It deletes provisions inconsistent with SB 10 (2022 Regular Session) and conforms to the new requirements of SB 10 for the number of students enrolled in a program of nursing. It also sets requirements for new programs of nursing opened during the period the emergency regulation was in effect.
  - (b) The necessity of the amendment to this administrative regulation: It is required by SB 10.
  - (c) How the amendment conforms to the content of the authorizing statutes: By deleting inconsistent provisions and adding new language to conform to the requirements of SB 10.
  - (d) How the amendment will assist in the effective administration of the statutes: By complying with SB 10.
  
- (3) List the type and number of individuals, businesses, organizations, or state and local governments affected by this administrative regulation: Prelicensure RN and LPN programs of nursing, approximately 100.
  
- (4) Provide an analysis of how the entities identified in question (3) will be impacted by either the implementation of this administrative regulation, if new, or by the change, if it is an amendment, including:
  - (a) List the actions that each of the regulated entities identified in question (3) will have to take to comply with this administrative regulation or amendment: They will have to report the number of students enrolled as well as the number to be increased to the Board. New programs opened during the period the emergency regulation was in effect will have to comply with 201 KAR 20:280.
  - (b) In complying with this administrative regulation or amendment, how much will it cost each of the entities identified in question (3): It is impossible to determine the cost.
  - (c) As a result of compliance, what benefits will accrue to the entities identified in question (3): They will no longer have a limit on the number of students they may enroll as long as they meet standards.
  
- (5) Provide an estimate of how much it will cost the administrative body to implement this administrative regulation:
  - (a) Initially: It is impossible to determine the cost. However, it is anticipated that all costs will be subsumed in the general operating budget.
  - (b) On a continuing basis: Same answer as (a).

**(6) What is the source of the funding to be used for the implementation and enforcement of this administrative regulation: Agency funds.**

**(7) Provide an assessment of whether an increase in fees or funding will be necessary to implement this administrative regulation, if new, or by the change if it is an amendment: No increase is necessary.**

**(8) State whether or not this administrative regulation establishes any fees or directly or indirectly increases any fees: It does not.**

**(9) TIERING: Is tiering applied? Tiering is not applicable since the changes affect all equally.**
