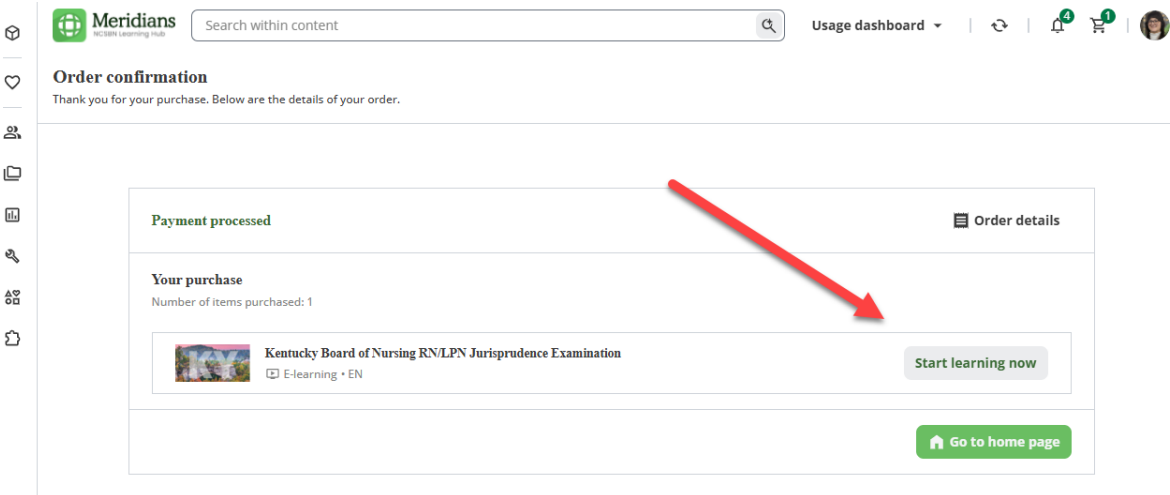

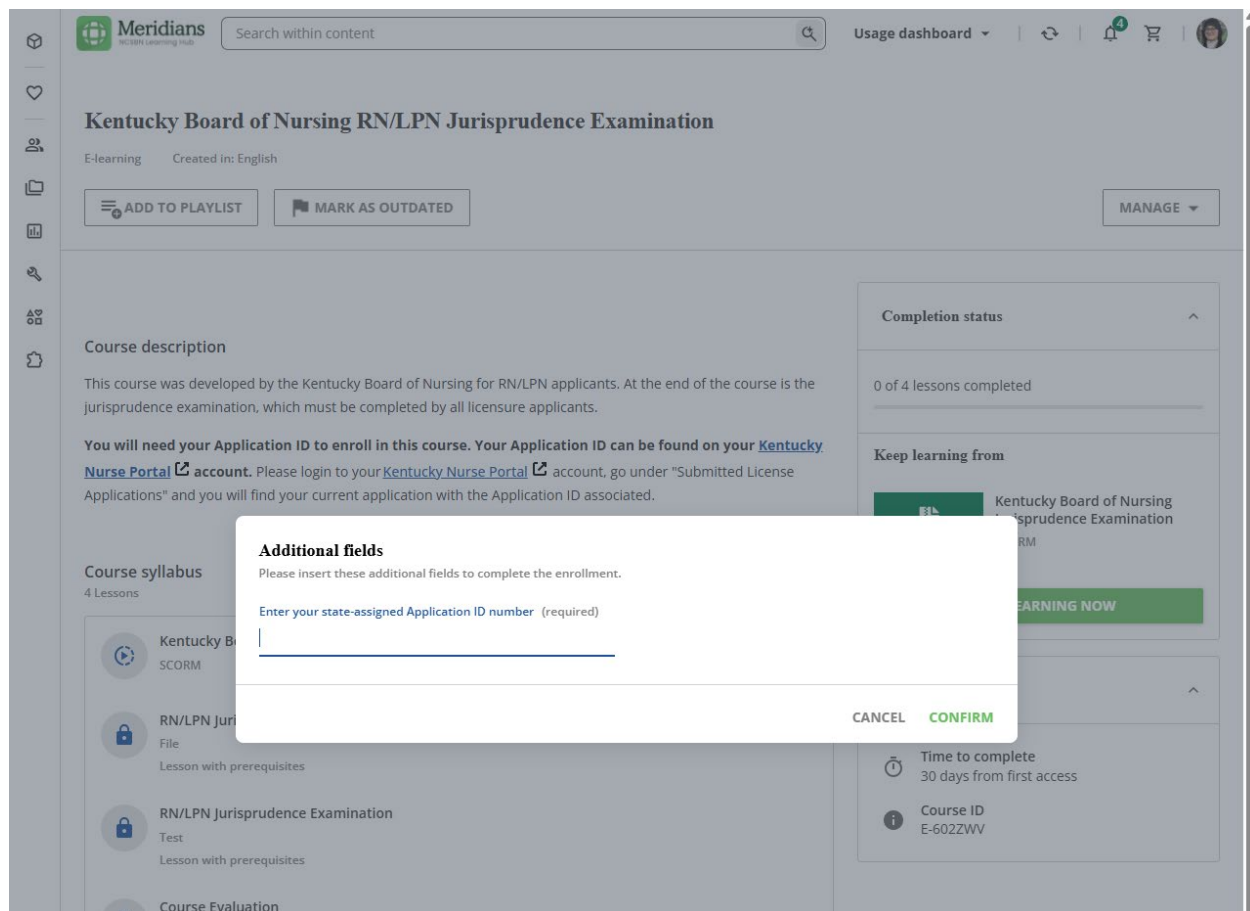

6. The next screen will either confirm the payment processed or state the payment was declined. To access the course directly, users can click “Start learning now.” Otherwise it will be available on their dashboard. They will receive an email notification confirming enrollment with a link to the course as well.



7. Once the user opens the course, they will be prompted to submit their state-assigned Application ID number. Once the ID number is provided, they can continue with the course.
