

# KENTUCKY BOARD OF NURSING SUMMARY OF MAJOR ACTIONS

*Board Meeting • February 18, 2021*

## STAFF RECOGNITION

Kimberly Nooning was recognized for five years of service to the Kentucky Board of Nursing.

## PRESIDENT'S REPORT

Dr. Wilson reported that the Executive Director position has been posted.

- IT WAS MOVED AND SECONDED THAT THE BOARD RESCIND THE BOARD'S PRIOR DECISION IN DECEMBER TO APPOINT THE FULL BOARD AS THE SEARCH COMMITTEE FOR A NEW EXECUTIVE DIRECTOR, AND ALLOW DR. WILSON TO APPOINT A SMALLER SEARCH COMMITTEE COMPOSED OF BOARD MEMBERS AND KBN STAFF. THE BOARD APPROVED THE RECOMMENDATION WITH NO ONE VOTING IN OPPOSITION AND NO ONE ABSTAINING FROM THE VOTE.

This change promulgates the New Nurse Licensure Compact Commission Rules, as required by KRS 314.475 Art. 1(c)(2).

- o IT WAS MOVED AND SECONDED THAT THE AMENDMENTS TO THE KBN APPLICATION AND KBN RENEWAL APPLICATIONS BE APPROVED, WHICH WERE APPROVED BY ACCLAMATION.

The approved amendments include:

- Add a question regarding branch of military service to reduce the error rate (erroneous "yes" response to military service question);
- Add clarification in conviction

questions to specify that traffic misdemeanors other than DUIs should not be reported, in conformity with the governing regulation;

- Remove KHEAA reference from attestation in light of complete elimination of KHEAA- based licensure discipline, which was implemented as a statutory change in 2019;
- Add statement related to primary state of residence, to indicate that verification of PSOR may be requested;
- Change header for address section from “Data Corrections: Complete ONLY if Needed” to “Current Mailing Address” as applicants will be required to fill out their current address with each renewal application, as the feature of prepopulating address with the previous year’s address is being removed to reduce the error rate; and
- Change publication date of this version of the application.



# An Overview of Dialysis Technicians

The Dialysis Technician (DT) is an individual who:

- Holds a DT credential issued by KBN.
- Meets standards from the Centers for Medicare and Medicaid Services (CMS), including:
  - Meet all applicable state requirements for education, training, credentialing, competency, standards of practice, certification, and licensure in the state in which he or she is employed as a dialysis technician;
  - Have a high school diploma or equivalency;
  - Have completed a training program that is approved by the medical director and governing body, under the direction of a registered nurse, focused on the operation of kidney dialysis equipment and machines, provide direct patient care, and communication and interpersonal skills, including patient sensitivity training and care of difficult patients.


In Kentucky, as of April 30, 2021, there are 706 credentialed dialysis technicians and 128 dialysis centers.

There are nine KBN approved DT training programs:

To become a DT, an individual may choose to complete training at any of the above DT training programs in Kentucky. However, that does not limit an individual on where he or she may obtain DT training. An individual may also attend an out-of-state DT training program offering didactic and clinical components. Please note should an individual choose to attend an out-of-state program, they will be required to submit documentation to confirm course comparability and complete additional Kentucky specific regulatory requirements. The regulatory requirements from 201 KAR 20:470 include:

3. A dialysis technician applicant who has completed an out-of-state dialysis technician training program shall be required to complete that portion of a board-approved dialysis technician training program related to specific portions of the legal and ethical aspects of practice as established in the Dialysis Technician Training Program Guide.
4. An applicant shall submit evidence to the board of successful completion of the following sections of the Dialysis Technician Training Program Guide:
  - a. State and Federal Regulations Governing Dialysis;
  - b. The Principles and Legal Aspects of Documentation, Communication and Patient Rights;
  - c. The Roles of the Dialysis Technician and other Multidisciplinary



- a. Team Members; and
  - d. Principles Related to Patient Safety.
5. A dialysis technician applicant who has completed an out-of-state dialysis technician training program shall submit the completed Checklist for Dialysis Technician Competency Validation signed by the applicant's immediate supervisor in Kentucky. The Checklist for Dialysis Technician Competency Validation shall be filed after the submission of the Application for Dialysis Technician Credential.
  6. A dialysis technician applicant who has completed an out-of-state dialysis technician training program shall submit evidence of:
    - a. Successful completion of a comprehensive, written final examination from a board-approved dialysis technician training program; or
    - b. Dialysis technician certification issued within the past two (2) years by the Nephrology Nursing Certification Commission, the Board of Nephrology Examiners Nursing and Technology, or the National Nephrology Certification Organization.

To become a credentialed DT in Kentucky, an individual must complete a DT Training Program and the Kentucky specific regulatory requirements. The individual must complete the Application for Dialysis Technician Credential, pay the initial application fee (\$70), complete a state and federal criminal background check through IdentGO, and comply with any other applicable requirements that are outlined on the KBN website, [www.kbn.ky.gov](http://www.kbn.ky.gov). Upon completion of the application process, the board shall issue the appropriate DT credential for a period of twenty-four (24) months following the month of issuance.





# An Overview of Sexual Assault Nurse Examiners (SANE)

The Sexual Assault Nurse Examiner (SANE) in Kentucky is a registered nurse who:

- Holds an RN license in Kentucky or another compact state.
- Holds a SANE credential issued by KBN.
- Is trained in the forensic examination of individuals and adolescents, defined as “a child who has reached the onset of physiological normal puberty,” or older who have been the victim of sexual assault.
- Collects and preserves evidence and testifies in legal proceedings in accordance with Kentucky law.

In Kentucky, as of April 30, 2021, there are 318 SANE credentialed nurses and fourteen SANE ready hospitals:

To become a SANE nurse in Kentucky, an individual may choose to complete training at any of the above SANE Training Programs. However, that does not limit a nurse on where he or she may obtain SANE training, or if a nurse chooses to obtain graduate education as a Forensic Nurse. A nurse may also attend an out-of-state SANE Training Program offering didactic and clinical components. Please note should a nurse choose to attend an out-of-state program, they will be required to submit documents to confirm course comparability and complete additional Kentucky specific regulatory requirements. Additionally, the online SANE training course offered by the International Association of Forensic Nurses (IAFN) meets the requirements for SANE credentialing in Kentucky. This course provides 43 contact hours of didactic training, but the clinical component must be completed in addition to Kentucky specific regulatory requirements. The regulatory requirements from 201 KAR 20:411(2)(6) are listed as follows:

1. Observing live or previously recorded criminal trials and meeting with the Commonwealth Attorney or a representative from the Commonwealth Attorney’s office in order to gain an understanding of the trial process including testifying;
2. Meeting with the local rape crisis center and a rape crisis center victim

advocate in order to gain an understanding of the services provided to victims by rape crisis centers and the role of an advocate;

3. Meeting with local law enforcement officers or investigators responsible for investigating reports of rape or sexual assault in order to gain an understanding of the investigative process; and
4. Application of the Kentucky statewide medical protocol relating to the forensic and medical examination of an individual reporting sexual assault pursuant to KRS 216B.400(2),(4),and (5). The victim’s bill of rights, KRS 421.500 through 421.575.

(b) In addition to the requirements of paragraph (a) of this subsection, the SANE-P/A course shall include:

1. Principles of child development;
2. Techniques for acute evaluations;
3. An overview of Kentucky Child Advocacy Centers; and
4. An overview of KRS 431.600 through 431.660 which shall include information about multidisciplinary teams and their functions, model protocols approved by the Kentucky Multidisciplinary Commission on Child Sexual Abuse, and the role of peer review in child sexual abuse cases.

To become a SANE credentialed nurse in Kentucky, an individual must be a licensed RN in Kentucky or another compact state and complete a SANE Training Program, including the Kentucky specific regulatory requirements. The individual must complete the Sexual Assault Nurse Examiner Application for Credential, pay the application fee established in 201 KAR 20:240 (\$120), complete a state and federal criminal background check through IdentoGO, and comply with any other applicable requirements that are outlined on the KBN website, [www.kbn.ky.gov](http://www.kbn.ky.gov). Upon completion of the application process, the board shall issue the appropriate SANE credential for a period ending October 31.



# An Overview of CNMs and LCPMS

When seeking health care from adolescence through menopause, women may choose different providers for primary care; gynecologic care; family planning and preconception care; and during pregnancy, birth, postpartum and newborn care. Throughout these experiences, women may receive care from healthcare professionals in various settings, including:

- Medical assistants, nursing assistants, and other unlicensed assistive personnel (UAPs)
- Nurses including licensed practical nurses (LPNs) and registered nurses (RNs)
- Advanced practice registered nurses (APRNs)
- Physician assistants (PAs)
- Physicians

Women seeking care during pregnancy, birth, and postpartum may choose to be cared for by one or more licensed independent providers (LIPs) below. In addition to selecting a provider, women may also choose for their care and birth experience to occur in hospitals, birthing centers, or in their homes. However, due to preference or unforeseen circumstances, a woman may be transferred to a higher level provider or care setting. Each LIP has a scope and standard of practice that is determined by educational experience and training, certification, professional organizations, and individual state laws.

- Physicians providing care to pregnant women may specialize in family practice, obstetrics/gynecology (OB/GYN), or perinatology – OB/GYNs who specialize in maternal fetal medicine and high-risk pregnancies. Physicians complete undergraduate education, medical school, residency, and often obtain board certification in their specialty. Physicians typically provide care to women in hospital settings, but may choose to do so in any birth setting.
- APRNs may specialize in family practice, women's health, or midwifery. A certified nurse midwife (CNM) is an APRN who has completed nursing school (baccalaureate prepared), holds a RN license, and has completed additional advanced education, training, and certification. CNMs are the only APRNs who are able to provide care to women during childbirth in any birth setting.
- In Kentucky and 36 other states, women may also seek care from professional midwives where the profession is regulated in that state.<sup>1</sup> A LCPM is a direct entry midwife who has a different pathway for training and clinical experiences than from CNMs. LCPM education and clinical training focuses on providing midwifery care to women who have a low-risk pregnancy and childbirth. Care is often provided in homes and freestanding birth centers rather than in hospitals and physician practices.
- Additionally, women may choose to have a doula to provide physical, emotional, and informational support. A doula is not licensed like the above healthcare professionals and does not perform clinical or medical tasks or diagnose and treat, but works as part of a woman's team to achieve a healthy, safe, and satisfying birth experience.

The Kentucky Board of Nursing is charged with the task of regulating LPNs, RNs, APRNs, and LCPMs, and does not have jurisdiction or provide regulatory guidance for medical assistants or other UAPs or physicians.

In Kentucky, as of April 30, 2021, there are 24 LCPMs and zero LCPM training programs. There are 126 CNMs and one CNM graduate program.

To become a LCPM in Kentucky, an individual may choose to complete their training and education from any CPM training program in the United States that is accredited by the Midwifery Education Accreditation Council (MEAC). Additionally, the individual shall provide evidence of having passed the North American Registry of Midwives (NARM) Examination and been granted certification by NARM. To become a CNM in Kentucky, an individual may choose to complete their training and education from any nursing and graduate nursing program in the United States. The individual must have an active RN license and APRN licensure with CNM certification. 

The Kentucky Women's Cancer Screening Program (KWCSPP) offers FREE breast and cervical cancer screenings. The program provides Mammograms and Pap tests and follow-up services, education and outreach to low income, eligible women. Once in the program, if a woman has an abnormal screening, the KWCSPP covers the cost of most diagnostic tests. If a pre-cancer or cancer is found, the program connects her to treatment through Medicaid's Breast and Cervical Cancer Treatment Program (BCCTP). The KWCSPP provides services through Kentucky's local health departments, community health clinics and other healthcare providers. A woman does not have to reside in the same county in which she receives services. Healthcare providers, please refer eligible women to a participating KWCSPP clinic/provider.
