## Board of Nursing Statement of Philosophy

It is the philosophy of the Kentucky Board of Nursing that the regulation of the practice of nursing shall achieve public protection by ensuring the competency of licensees who provide nursing care. To that end, the regulation of nursing should be responsive to the changing health application of knowledge, skills, and behavior to meet those needs and priorities. As public protection is the essential role of the Board, the public should have a voice in the action taken to promote its protection.

Licensure establishes an essential level of competency, and indicates that nurses have a common core of knowledge. As such, the purpose of licensure is to set standards for practice and education of individuals in order to protect the public from dishonest and incompetent practitioners. These standards are established in the *Kentucky Nursing Laws* (Kentucky Revised Statutes Chapter 314) and its attendant administrative regulations. Nursing practice and behavior inconsistent with these standards should lead to disciplinary action.

Critical elements of the regulation of nursing practice include a coherent, generally acceptable definition of nursing, as well as definitions of professional scope and accountability. These definitions should make explicit that the nurse is responsible and accountable for the practice of nursing according to individual preparation and experience, with nursing auxiliaries assisting under prescribed conditions. Further, the licensed nurse is responsible and accountable for continued professional learning throughout her/his career continuum.

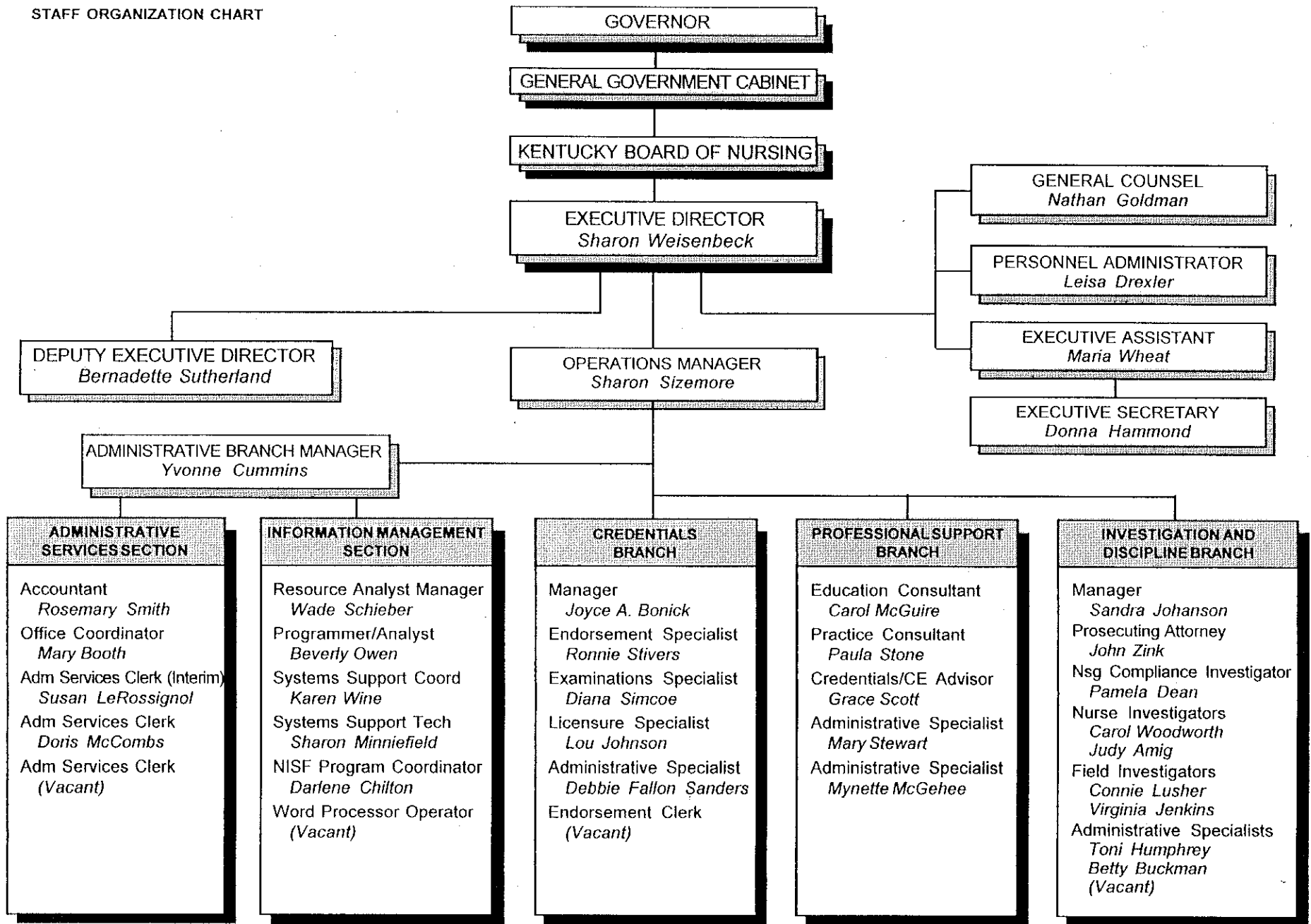
Essential components of the regulation of prelicensure nursing education include sufficient, qualified faculty and appropriate program curricula and clinical practice laboratories. The curricula should reflect the activities, functions, duties, and responsibilities of the practicing nurse. The clinical practice laboratories should allow prelicensure students opportunities to both generate new knowledge and demonstrate their practice abilities.

As the standards governing nursing practice, continuing education, and prelicensure education are established through the legislative process, the Board has a responsibility to maintain ongoing communication with the legislative branch of government. Concurrently, the complex and dynamic changes occurring in the health care delivery system require that effective communication be maintained with licensees and with local, state and national nursing organizations, health care providers and agencies, governmental units, and nursing education programs.

In summary, the Kentucky Board of Nursing believes that the protection of the public can best be accomplished through ensuring the competency of licensees who provide nursing care, and by establishing standards that allow for the fullest development of nursing practice, commensurate with its potential social contribution.

## Highlights of Board Activities

This Annual Report provides a synopsis of the various activities conducted by this agency to fulfill its charge to regulate the practice of nursing in order to protect and safeguard the health and safety of the citizens of the Commonwealth of Kentucky [Reference: KRS 314.021(1)].

Highlights of this years' activities are listed below.

- ◆ At the invitation of the Kentucky Hospital Association Center for Nursing and Allied Health Professions, agreed to participate as a member of a task force to study the use of unlicensed assistive personnel in Kentucky.
- ◆ Directed that prelicensure programs of nursing may elect to have domestic violence curriculum content reviewed and validated for consistency with statutory requirements [KRS 194.540(2)]. If the curriculum content is judged to meet statutory requirements, subsequent graduates of the program will be determined to have met the one-time mandatory domestic violence continuing education requirement.
- ◆ Directed that terms in Agreed Orders be changed to require return of the license or ARNP registration card within 15 days of the date of a final Board order. Failure to return the license or ARNP registration card within 15 calendar days would result in immediate suspension/revocation of the license or ARNP registration.
- ◆ Approved stayed suspension language for immediate use in Agreed Orders.
- ◆ Directed that appointment of a KBN hearing officer position be pursued.
- ◆ Directed that the Board conduct a customer service survey to collect data for future development of the agency's strategic plan, and approved up to \$20,000 for developing, conducting and analyzing the survey.
- ◆ Directed that the Board continue to work with the Cabinet for Health Services, Department of Medicaid Services, and the Division of Licensing and Regulation to transfer the nurse aide register program to the Board office.
- ◆ Directed that general counsel research telephone hearings and develop criteria for such.
- ◆ Directed general counsel to request an opinion from the attorney general regarding the intent of House Bill 285 as it relates to in-service training on the determination of death by registered nurses.
- ◆ Directed staff to notify prelicensure registered nurse programs of nursing to inform all students of the Board's administrative regulations on the determination of death and preservation of evidence.
- ◆ Directed that Nancy Sylvester, Parliamentarian, be contracted with as a consultant, that she attend a Board meeting, meet with the Board Structure Work Group at the conclusion of the Board meeting, and make recommendations to the Work Group on the issue of how the Board conducts its business.

- ◆ Directed that the Board discontinue the practice of holding open forums and committee meetings at Kentucky state parks.
- ◆ Directed that the nurse administrator programs continue to be held as scheduled for 1999, that the name of the programs be changed to Nursing Leadership Programs, and that the matter be referred to the Study and Planning Committee for further consideration.
- ◆ Directed that the KBN annual conference be held again beginning in the year 2000.
- ◆ Directed that one of the current positions of the Board be designated as an ARNP.
- ◆ Directed that the Board move forward for planning implementation of a diversion program; that a work group consisting of experts in the field of establishing and maintaining diversion programs be appointed; and that the work group be appointed by the Consumer Protection Committee chairperson. Directed that the charge of the Work Group be to develop the plan for implementation of a Diversion Program to include program type, budget, structure, components, needed legislative proposals, Board decision points and submission of reports.
- ◆ Ratified approval of the statement entitled "Orientation of Graduate Nurses," and directed that the Study and Planning Committee monitor the implementation of this recommendation and report back to the Board.
- ◆ Directed that a domestic violence continuing education course offered by a KBN recognized provider be accepted; and that a domestic violence continuing education course offered by an organization approved by a related Kentucky health care professions regulatory Board be accepted.
- ◆ Directed that an Initial Competency Task Force be established for FY 1999-2000 to develop recommended regulatory standards for initial licensure as a nurse in the Commonwealth.
- ◆ Directed that default judgements be utilized in administrative hearings.
- ◆ Approved the proposed legislative changes to KRS Chapter 314 for the 2000 session of the General Assembly.
- ◆ Approved the proposed changes to KRS 314.011, KRS 314.073, and 201 KAR 20:215 related to competency validation.
- ◆ Recognized the Intravenous Nurses Society's standards entitled "Roles of Nurses in Intravenous Therapy Practice."
- ◆ Directed that regulatory language incorporating the standards of nursing competence enumerated in the position paper entitled "Accountability and Responsibility of Licensees to Assure Nursing Competence" be developed.
- ◆ Directed that the Competency Validation Communication Plan be implemented as applicable.

## Continuing Education

As a mechanism to promote continuing competency, the *Kentucky Nursing Laws* (KRS 314.073) mandate that licensees earn a minimum of 30 hours of approved nursing continuing education, including at least two hours of Kentucky Cabinet for Health Services (CHS) approved AIDS education (KRS 214.610). In addition, ARNPs must earn five contact hours in pharmacology as part of their 30-hour requirement. The Kentucky Board of Nursing (KBN) is the Commonwealth agency legally authorized to approve providers of mandatory continuing education (CE).

In 1996, the Kentucky General Assembly mandated that all nurses with active licensure status on July 15, 1996 must earn three hours of KBN approved domestic violence CE before July 1, 1999. This is a one-time earning requirement.

Any nurse licensed after July 15, 1996 has three years from the date of initial licensure to earn the one-time three hours of domestic violence CE. Compliance monitoring will include random audits following 1999 license renewals.

The post-renewal audit process is used to verify earning of the required 30 contact hours including the two hours of CHS approved AIDS education. The random audit requires that those persons selected show documented evidence (certificate of attendance, transcript, grade report, etc.) of approved contact

hour earning during the applicable licensure period. Of those licensees randomly selected for the audit process, 94.6% demonstrated compliance with the CE requirements, and 96.3% demonstrated compliance with the HIV/AIDS requirement. Those not complying were referred for disciplinary action.

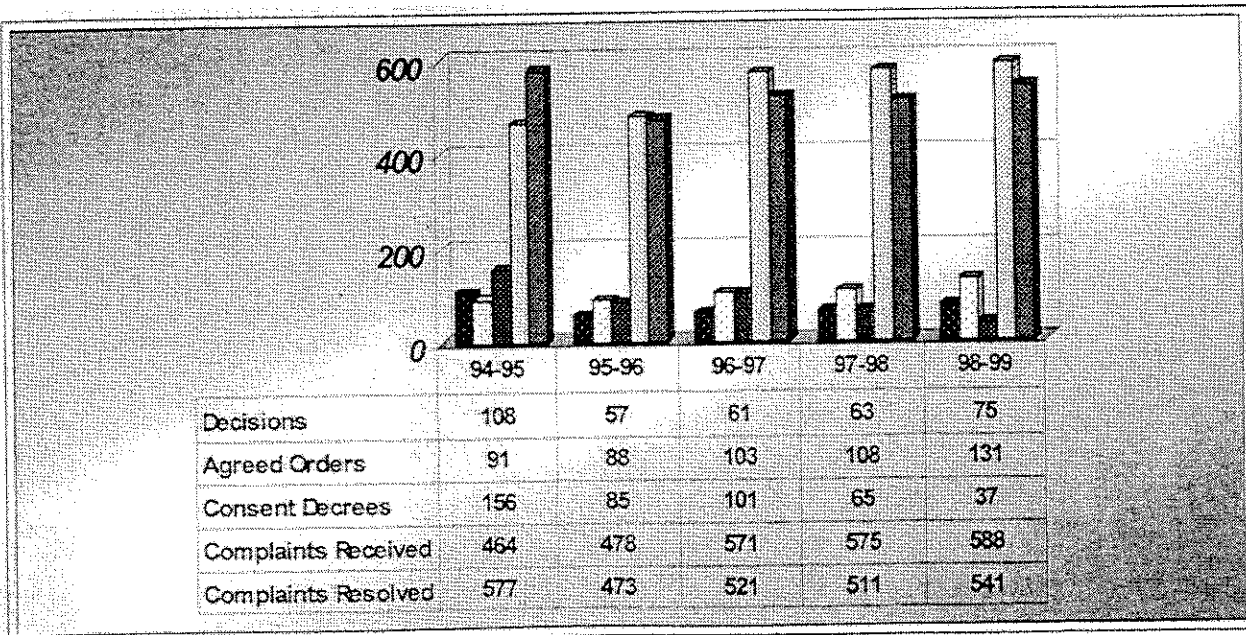

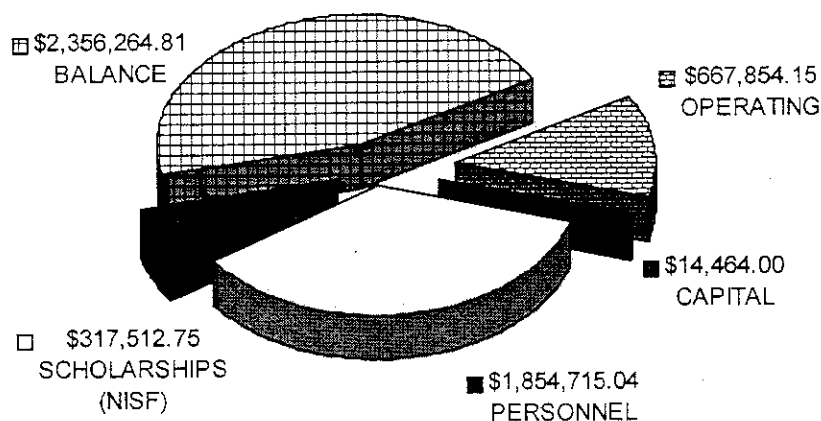
The Board continues its efforts to make the public aware of the investigatory and disciplinary procedures and to emphasize the legal requirement to, and importance of, reporting nurses who are suspected of engaging in unsafe or illegal practices.



## Financial Operations

### Financial Report

**FY 98-99: TOTAL FUND BALANCE = \$5,210,810.75**



The Kentucky Board of Nursing is a fee supported agency. No general revenue tax dollars are expended by the agency. The fund balance for FY 98-99 was \$5,210,810.75 with expenditures totaling \$2,854,545.94. Due to biennial licensure of nurses, funds from the balance are carried forward to meet the FY 2000 budget needs.

Various Board of Nursing publications and informational material were offered for a nominal fee that covered duplicating costs. Some of the publications available for purchase were the KBN History, *Kentucky Nursing Laws*, KBN Administrative Regulations, KBN Advisory Opinion Statements, and Disciplinary Process and Procedures for Nursing Licensure. Free brochures on continuing education and the criminal conviction process were also available.

## Nursing Practice

The Board interprets the legal scope of nursing practice according to the *Kentucky Nursing Laws* and Board of Nursing administrative regulations in the determination of safe and effective nursing care for the citizens of the Commonwealth. In response to inquiries requesting interpretation of the legal scope of nursing practice, the Board has published formal advisory opinion statements as guidelines for safe practice (see the chart below), as well as issuing other opinions on nursing practice matters.

During FY 98-99, the Board addressed the following inquiries regarding nursing practice: Administration of Etomidate during rapid sequence induction by RNs; performance of medical screening examinations by nurses as required by Code of Federal Regulations 29CFR 1910.134, Occupational Safety and Health Administration Respiratory Protection Standard; performance of colposcopies by RNs; and delegation of Diastat (Diazepam Rectal Gel) to unlicensed persons in a school setting by RNs.

## Nursing Incentive Scholarship Fund

The Nursing Incentive Scholarship Fund (NISF) provides scholarships to Kentucky residents for attending approved prelicensure nursing programs (registered nurse or practical nurse) or graduate nursing programs. Scholarship recipients must work as nurses in Kentucky for one year for each academic year funded. To be eligible for consideration, an applicant must have been admitted to a nursing program.

Students in prelicensure and BSN completion nursing programs must complete a minimum of eight (8) credit hours per semester of published requirements for the nursing program, and maintain a minimum grade point average which will allow continuation in the nursing program. For graduate nursing programs, students must complete a minimum of six (6) credit hours per semester of published requirements for the nursing program, and maintain a grade point average which will allow continuation in the graduate program.

## Nursing Education

### PROGRAMS OF NURSING

The Kentucky Board of Nursing is the legally authorized body in the Commonwealth to approve programs of nursing preparing persons for eligibility for licensure as nurses. Through the provisions of the *Kentucky Nursing Laws* and applicable Kentucky administrative regulations, the Board prescribes standards for educational institutions offering programs preparing candidates for licensure as nurses. As of June 30, 1999, there was a total of 10 baccalaureate nursing programs, 24 associate degree programs, and 18 practical nursing programs approved by the KBN.

### NCLEX PASS RATES

NCLEX using computerized adaptive testing was initiated in April 1994. With the computer delivery of NCLEX, eligible licensure candidates have been able to schedule the examination at a time of personal preference, within one year of being declared eligible to test by the Board. Fiscal year pass rates for first-time candidates is based on the number of graduates from a program of nursing during a fiscal year (i.e., July 1 through June 30) who test prior to December 31 of the subsequent fiscal year.

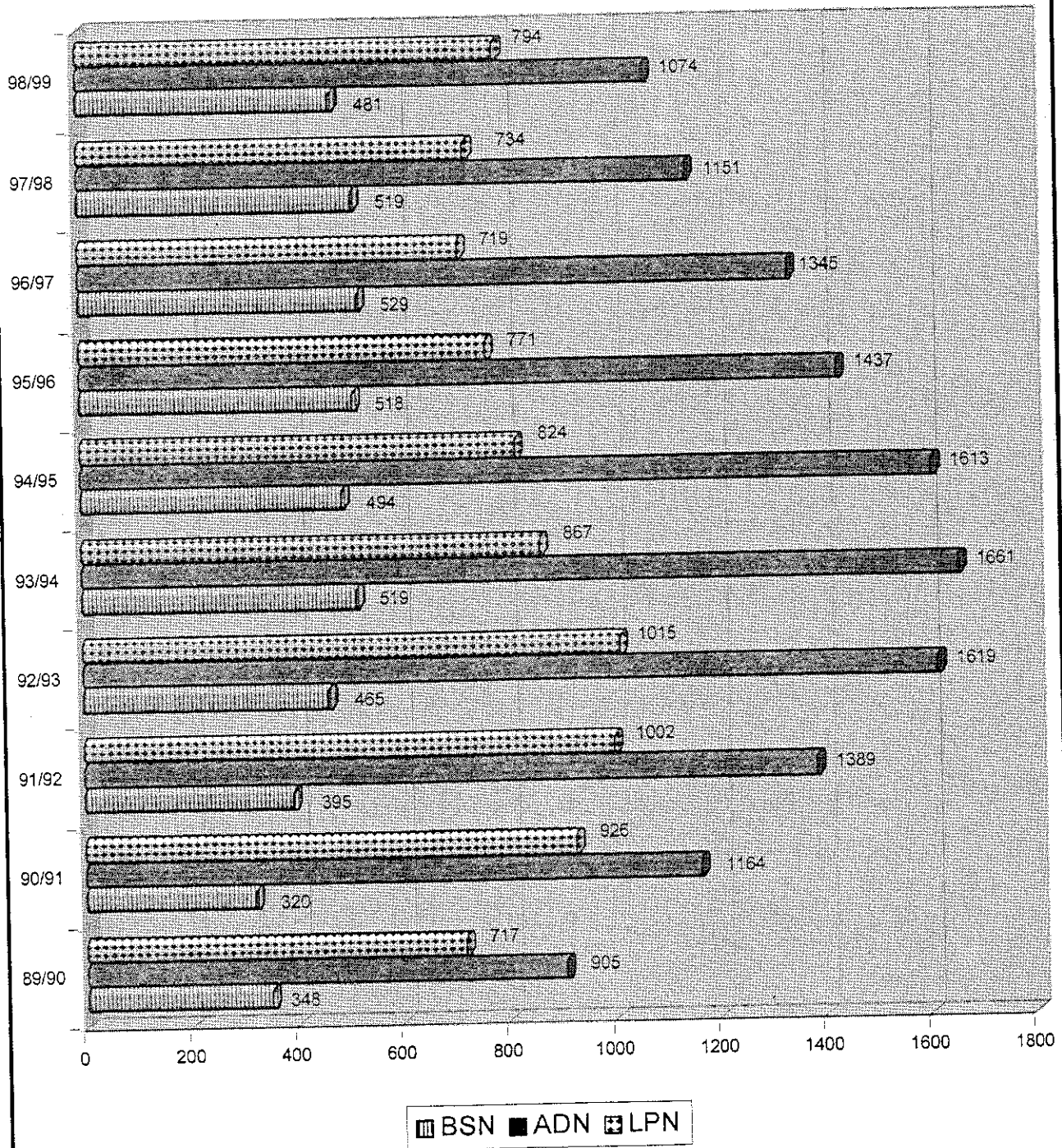

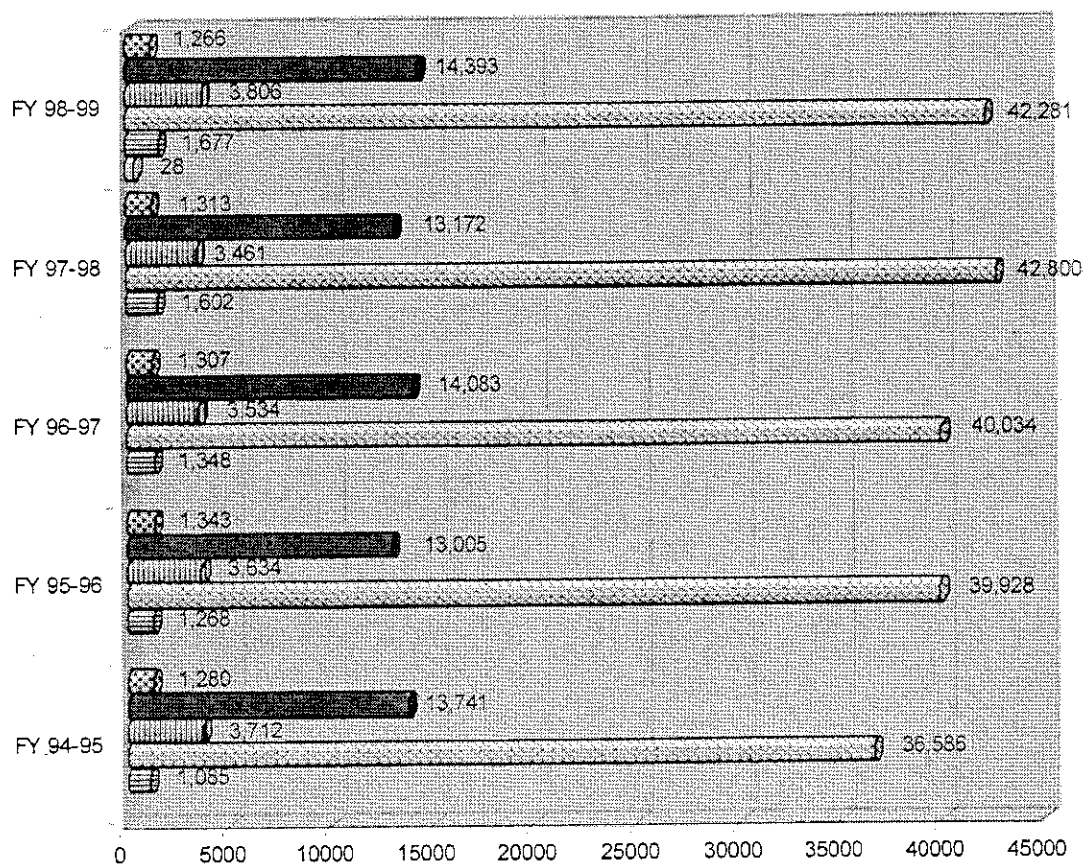

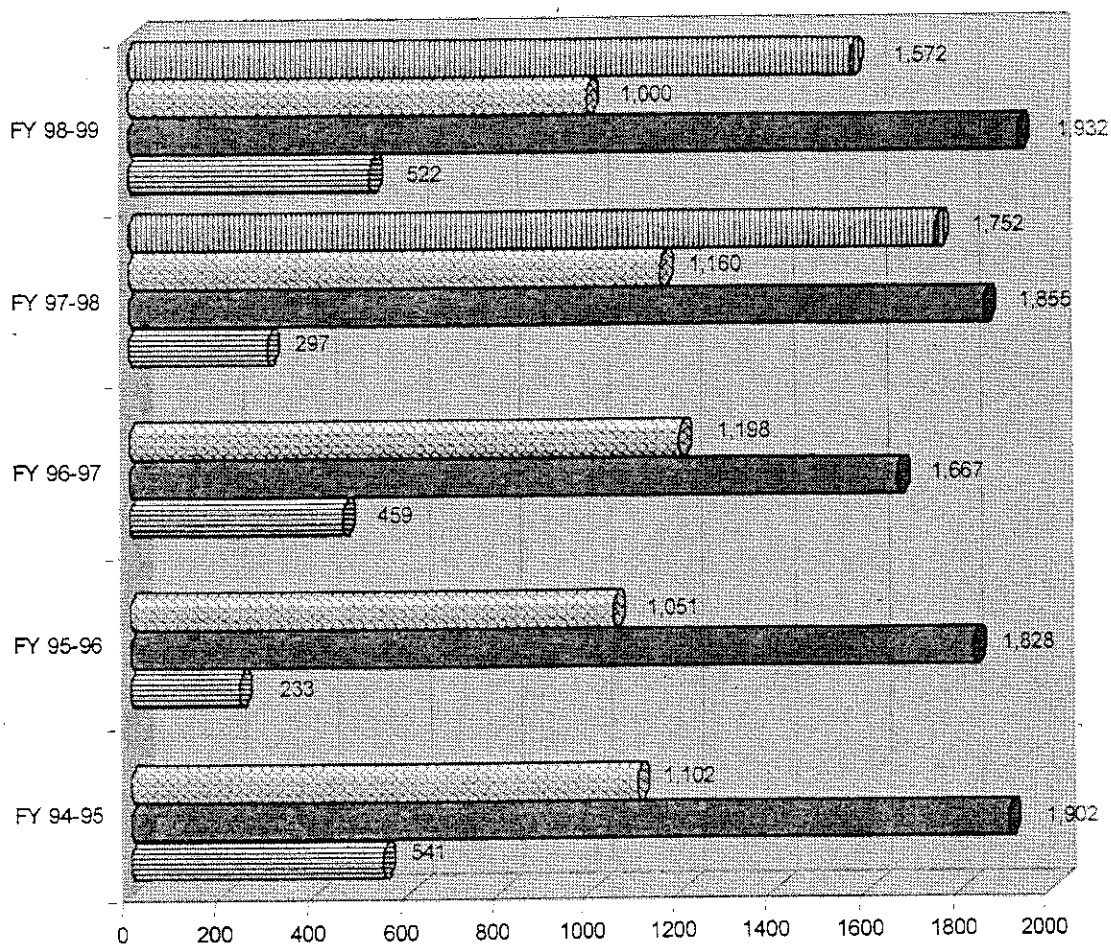
