President and Executive Director's Message



The focus of the Kentucky Board of Nursing this year has been one of transition: from reacting and responding to pandemic conditions to adopting and establishing regulatory and statutory measures to address the emergency issue of the nursing shortage in the Commonwealth. The Board has taken proactive measures to address the nursing shortage by establishing collaborative relationships to utilize data to developing workforce projections. Following significant changes in key staff leadership positions early in fiscal year 22, normalizing sound business practices of paperless processes, remote work and telecommuting has added to the sustainability of the health and welfare of the long-tenured staff of the agency. The Board has focused on 1) removing barriers in processes to license and credential individuals seeking to practice in Kentucky in addition to responding to the will of the General Assembly, 2) identifying, preparing for and securing technology platforms to streamline the work of the Board, and 3) stabilizing a staff structure while capitalizing on skills and expertise that were previously underutilized in several areas.

Amended KBN Regulations for FY2022

More than a dozen regulations were implemented through the emergency process as well as the normal administrative review which address requirements and processes for licensure, license renewal, program of nursing requirements and updated educational and credentialing requirements for dialysis technicians. SB10, signed April 7, 2022 integrated the essence of many of the nursing shortage-related regulations as well as amending Board membership, length of terms of office, and confirmation by the Senate.

Nursing Shortage in the Commonwealth

In addition to the regulatory and statutory changes that address processes of licensure, the KBN President and Vice President were appointed to Governor Beshear's Team Kentucky Nursing Advisory Committee. Recommendations from that report have been initiated or completed. KBN is also developing a build a robust workforce project model utilizing the mandatory data that will be collected upon license renewal in October 2022.

KBN Personnel

A new Executive Director began the end of the fiscal year 2021, the Deputy Executive Director passed away, a new Deputy was appointed, and a new HR Coordinator was appointed within the first 5 months of FY22. Telecommuting that was initiated with COVID precautions has continued and allowed the agency to recruit personnel with expertise from other areas of the Commonwealth. Additionally some

staff have been re-trained, promoted, and re-assigned, supporting retention of in-house staff while benefiting from their skills, talents, and expertise in new opportunities.

To honor the legacy of Michelle G. Rudovich, JD, KBN Deputy Executive Director from 2020-2021, the Michelle Grant Rudovich Award was instituted to recognize the attributes of a KBN employee who exemplifies Michelle's work ethic and her dedication to living life to the fullest. Staff are also encouraged to participate in KEAP Training and has been utilized in mandatory staff training events.

A new KBN logo was designed to give the Board a fresh identity. The KBN website has been updated and content repurposed for a more user-friendly approach for a self-service approach. Data management applications will be implemented in the coming months for efficiency, effectiveness, cyber-safety, and best business practices.

KBN Mission

The KBN stayed true to its mission of protecting the public. The KBN continued to license or credential nurses, dialysis technicians, and licensed certified professional midwives; regulate educational programs; investigate licensees and credential holders who were accused of violating KRS 314 and 201 KAR 20; monitor licensees and credential holders who had entered disciplinary monitoring; and worked with participants in the Kentucky Alternative Recovery Effort (KARE) for Nurses Program.

Purpose

The Advanced Practice Registered Nurse Council, in keeping with the mission of the Kentucky Board of Nursing, shall recommend standards of advanced practice registered nursing to the Kentucky Board of Nursing which protects the well-being of the public and ensures the safe practice of nursing. The Council shall recommend standards regarding the performance of acts requiring additional education. This includes the performance of acts relative to nurse anesthesia, nurse midwifery, nurse practitioner, and clinical nurse specialist practice.

Functions

- 1. Submits recommendations to the Board as needed.
- Submits to the Board new and/or revised regulations governing advanced practice registered nursing practice, education and registration to ensure safe and effective care to the citizens of the Commonwealth.
- 3. Advises the Board regarding the interpretation of the legal scope of advanced practice registered nursing practice as defined in KRS 314.011(8).

- 4. Reviews new and/or revised scope and standards of practice statements promulgated by national organizations cited in 201 KAR 20:057 (1) Scope and standards of practice of APRNs, and if acceptable by the Board, such statements shall be filed by reference to said regulation with the Legislative Research Commission.
- 5. Reviews new and/or revised regulations: 201 KAR 20:056 and 201 KAR 20:062 related to registration and education.
- Reviews new and/or revised regulations: 201 KAR 20:063 related to ordering, prescribing, and administering amphetamine like controlled substances and 201 KAR 20:065 relating to standards for prescribing Buprenorphine-Mono-Product or Buprenorphine-Combined-with-Naloxone for medication assisted treatment for opioid use disorder.
- 7. Advises the Board on the recognition of national certifying organizations that grant certification to meet eligibility requirements for registration as an advanced practice registered nurse.
- 8. Provides a forum for the representative members and organizations to express concern related to the education and delivery of health care by the advanced practice registered nurse.
- 9. Recommends objectives to be accomplished annually.
- 10. Submits an annual report to the Board.

- 1. That the 2020-2021 annual report for the Advanced Practice Registered Nurse council be approved as written.
- 2. That the 2021-2022 APRN council objectives, as presented, be approved.
- 3. That the 2021-2022 APRN council scope and functions, as presented, be approved.

- 6. That it is in the scope of practice for an advanced practice registered nurse who is educationally prepared and clinically competent to recommend or suggest the use of vitamins, diet and exercise regimens to patients.
- 7. That it is within the scope of practice of an advanced practice registered nurse (APRN) psychiatric mental health nurse practitioner (PMHNP) who has a credential in the use of RTMA and is educationally prepared possessing an extensive background in brain physiology received during completion of a training program in psychiatry and/or neurology and clinically competent to practice transcranial magnetic stimulation.
- 8. That it is within the scope of practice of an advanced practice registered nurse (APRN) CRNA to order and administer ketamine infusion for psychiatric disorders and chronic pain and that an AOS be created to discuss the collaboration and use of ketamine in non-acute settings.

Purpose

Pursuant to KRS 314.402 (1), the Licensed Certified Professional Midwives Advisory Council shall meet at regular intervals, and guided by newly available evidence in peer-reviewed medical literature, advise the Board on promulgating administrative regulations regarding qualifications, standards for training, competency determination of licensed certified professional midwives, any necessary statutory changes, and all other matters relating to licensed certified professional midwives (LCPM).

Functions

- 1. Submits recommendations and new or revised regulations to the Board governing licensed certified professional midwives and certified professional midwifery services to ensure safe and effective care for the citizens of the Commonwealth.
- 2. Advises the Board regarding certified professional midwifery services and licensed certified professional midwives as defined in KRS 314.400.
- 3. Advises the Board on the national certifying organization, North American Registry of Midwives (NARM) which grants certifications required to meet competency validation requirements and the Midwifery Education Accreditation Council (MEAC) which accredits education programs.
- 4. Provides a forum for the representative members and organizations to express concern related to the education and delivery of health care by licensed certified professional midwives.
- 5. Recommends objectives to be accomplished annually.
- 6. Reviews LCPM Incident Reports and Annual Reports
- 7. Submits an annual report to the Board.

Functions

- 1. Furnish guidance to staff for the resolution of disciplinary complaints or issues related to KARE for Nurses Program participants or potential participants that fall outside the scope of available precedent because of factual, evidentiary, legal, or equitable consideration.
- 2. Propose recommendations and review guidelines for a specific licensee/applicant for licensure, credential, disciplinary matter, and KARE for Nurses Program participation.
- 3. Refer issues raised by disciplinary cases or the KARE for Nurses cases to the Credentials Review Panel for consideration while preserving the confidentiality of the case(s) involved.
- 4. Review of applicants for licensure or credentialing.
- 5. Serve as resource to staff as needed.
- 6. Submit annual statistical reports to the Board and other reports as necessary while preserving the confidentiality of the case(s).
- 7. Review conviction records and give direction for disposition.
- 8. Review disciplinary action imposed upon a licensee/applicant's other professional license or nursing license in another jurisdiction and give direction for disposition.

- 9. Review medical malpractice payment reports and consider information for direction.
- 10. Furnish guidance regarding amendments to existing Agreed Orders.
- 11. Review information related to the Nurse Licensure Compact and disciplinary issues. Credentials Review Panel Scope, Functions and Membership.

 - a. In section 4(2) add the same language regarding the waiver of educational requirements for program administrators to also apply to assistant program administrators.
 - b. Add the same language from section 1 regarding granting program administrators a 5year grace period for obtaining ABSN to also apply to assistant program administrators.

- c. In section 5(4) add the same educational waiver statement to also apply to bachelor's degrees for didactic faculty.
- d. In section 6(d) amend the 160-hour internship requirement to only apply to persons who have 2 unsuccessful attempts on the final exam. Prior to the 3rd exam attempt, completion of a 160-hour internship is required.
- e. To defer the gathering of data related to exam attempts and subsequent reporting of that data to a subcommittee.

The purpose of the Education Committee is to consider matters related to pre-licensure PN, RN, MSN/APRN and DNP/APRN education in the Commonwealth, and mandatory continuing education/competency.

Functions

- 1. Initiate, review and/or recommend statutes and/or administrative regulations governing nursing education and continuing competency.
- 2. Review and recommend program approval status of pre-licensure nursing programs, including MSN/APRN and DNP/APRN programs.
- 3. Assess and respond to programs of nursing in relation to compliance with regulatory requirements.
- 4. Stay informed of trends and issues that impact the knowledge base for nursing practice within the nursing education and continuing competency.

- 1. The staff NISF scholarships report was approved as written.
- 2. The 2020-2021 annual report for the Education Committee was approved as written.
- 3. That the additional revisions to the 2021-2022 Education Committee scope and functions, as stated, be enacted; and
- 4. That the revised 2021-2022 Education Committee objectives, as revised, be approved
- 5. That the additional revisions to the 2021-2022 education committee objectives, as stated, be enacted. And
- 6. That the revised 2021-2022 Education Committee objectives, as revised, be approved
- 7. That the following proposed revisions to 201 KAR 20:280 and 201 KAR 20:360 be approved:
 - a. That the proposed revisions be amended to stipulate that programs of nursing are to achieve candidacy in three years and full accreditation in four years; and
 - b. That the proposed revisions to 201 KAR 20:280, and subsequent revisions to section 7(4) be accepted with amendments; and
 - c. That the proposed revisions to 201 KAR 20:360 be accepted with amendments
- 8. That the following proposed revisions to 201 KAR 20:220 be approved:
 - a. Section 5 of the proposed revision of 201 KAR 20:220 be updated to reflect October 2021; and
 - b. That the proposed revisions to 201 KAR 20:220 and the Material Incorporated by Reference (MIR) be accepted as amended
- 9. That NCSBN be invited to speak at the next education committee meeting to discuss the service they offer for producing annual reports; and
- 10. That further action regarding revisions to the KBN annual report be deferred until more information is available regarding the capabilities, advantages, and disadvantages of the annual report service offered by NCSBN.
- 11. That the following proposed revisions to 201 KAR 20:320 be approved:
 - a. The definition of external examinations as given in the committee's first recommendation above, be moved to section 1(3) after the statement ending in "not produced by a program of nursing," such that section 1(3) would read:
 - i. "External examination" means a standardized norm-referenced examination that is designed to compare and rank test takers in relation to one another and is not produced by the programs of nursing.
 - b. The definition of remediation given in section 1(7), strike the second clause, to state as follows:
 - c. "Remediation" means the process by which a student improves or corrects a knowledge deficit through external examinations, other assignments, or activities.
 - d. The previous definition of external examinations be reinstated as previously given in section 4 (1), "is a standardized or norm referenced examination that is designed to compare and rank test takers in relation to one another and is not produced by the program of nursing"
 - e. In section 4(2), the first clause be stricken up to the comma, and the sentence be amended to state: "a program of nursing shall not use an external examination as the sole basis to determine a student's progression or graduation"
 - f. Section 4(4), which stated, "an external examination may be used to assist in the remediation of a student", be stricken, as it would be redundant following the proposed changes to section 4(1)
 - g. In section 4(7), strike the first two clauses of the paragraph so that it only states:

- h. A program of nursing shall not require students who have completed all requirements for graduation to earn a specific score or benchmark on an external examination as a condition for graduation or for placing the student's name on the certified list of Kentucky program of nursing graduates pursuant to 201 KAR 20:070.
- 12. That the request, dated May 3, 2021, to increase the baseline enrollment of Bellarmine University's BSN program from 184 students per year to 212 students per year be accepted.
- 13. That board staff create, distribute and provide the findings from a survey to other boards of nursing to collect information on what approval statuses are in use in other states;
- 14. That board staff draft some language regarding benchmarks triggering board action.
- 15. That that the board consider deferring regulations 201 KAR 20:280 and 201 KAR 20:360 for two reasons: a.) Consideration of NCSBN annual report template adoption and b.) Consideration of reintroducing a probationary status.
- 16. That Bellarmine University Lansing school of Nursing and Clinical Sciences letter of intent to establish an additional CRNA program track, within the doctor of nursing practice (DNP) degree program be granted approval and invited to submit a proposal within one (1) year of the date the approval.

Purpose

The purpose of the Practice Committee is to consider those matters related to the interpretation of the legal scope of nursing practice as defined in Kentucky Revised Statutes Chapter 314 and Board of Nursing administrative regulations. Committee deliberations may include review of other relevant statutes and regulations as necessary.

Functions

- 1. Studies nursing practice issues related to the legal scope of nursing practice.
- 2. Assists in the review, revision or initiation of administrative regulations pertaining to nursing practice as authorized by KRS Chapter 314.
- 3. Develops guidelines and advisory opinion statements on matters related to nursing practice.
- 4. Submits recommendations to the Board on matters related to the function.

- 1. That the 2020-2021 annual report for the Practice Committee be approved as written.
- 2. That the 2021-2022 Practice Committee scope and functions, with specific revisions, be approved.
- 3. That the 2021-2022 Practice Committee objectives, with specific revisions, be approved.
- 4. That the following advisory opinions not incorporated into advisory opinion statements be reaffirmed:
 - A. Bowel and bladder program care as issued October 2018
 - It is within the scope of practice for the LPN, RN, or APRN, who is educationally prepared and clinically competent, to perform bowel and bladder program care including intermittent urinary catheterization and digital rectal stimulation. These acts are considered to be nursing tasks.
 - II. An RN or APRN may delegate these tasks to unlicensed personnel who are trained and competent to perform the tasks under an established plan of care developed after an assessment of the patient by an RN, APRN, or physician.

- III. Under KRS 205.900(3), 910 KAR 1:090, and AOS #15, these tasks are not considered to be the practice of nursing when the performance is directed by the client, the client's family, the client's legal guardian, or the client/client family/legal guardian's delegate.
- IV. An RN or APRN, who is educationally prepared and clinically competent in the performance of bowel and bladder program tasks, may train unlicensed individuals in the performance of bowel and bladder program related tasks.
- V. It is not within the scope of practice for an LPN to train unlicensed individuals in the performance of bowel and bladder program related tasks.
- B. Paracentesis as issued February 2019:
 - I. The licensed practical nurse provides assistance to the physician, physician assistant, or APRN during paracentesis. It is not within the scope of practice of the LPN to monitor a patient nor to adjust, or remove a paracentesis catheter.
 - II. It is within the scope of practice of a registered nurse who is educationally prepared and clinically competent to assist the physician, physician assistant, or APRN in the performance of a paracentesis procedure, and to monitor the patient once the catheter has been inserted by a physician, physician assistant, or APRN and to remove the catheter.
 - III. It is not within the scope of practice of a registered nurse to adjust the paracentesis catheter.
 - IV. It is within the scope of practice for an advanced practice registered nurse, who is educationally prepared and clinically competent, to perform ultrasoundguided paracentesis procedures.
- C. Thoracentesis as issued June 2019:
 - I. It is within the scope of practice of a registered nurse who is educationally prepared and clinically competent to remove a thoracentesis catheter after it has been inserted.
 - II. The physician, physician assistant, or APRN must remain onsite during removal of the thoracentesis catheter by the registered nurse, monitoring for an adverse outcome.
 - III. It is within the scope of practice of an APRN who is educationally prepared and clinically competent to perform thoracentesis procedures.
- D. Therapeutic phlebotomy, RN nursing practice as issued June 2016:
 - The performance of therapeutic phlebotomy (removal of a large volume of blood via a central venous access device), is within the scope of the registered nursing practice for the nurse who is educationally prepared and clinically competent in the performance of the procedure.
 - II. The performance of therapeutic phlebotomy should be in accordance with documented facility policy and procedure as well as current evidence based practice.
- E. Gastric band adjustment, RN and LPN scope of practice as issued in October and December 2014:
 - It is within the scope of registered nursing practice for an RN who is educationally prepared and currently clinically competent to perform gastric band adjustments under the supervision of a physician or APRN. There should be documented evidence of the registered nurse's educational preparation and current clinical competence. The RN should follow written policy and


procedures and evidence-based protocols agreed upon by the medical and nursing staff and formally adopted by the facility, organization or practice.

- II. The performance of gastric band adjustment is within the scope of practice of the RN the performance of gastric band adjustment is not within the scope of licensed practical nursing practice.
- F. Dynamic endocrine testing, LPN scope of practice as issued April 2015:
 - It is within the scope of licensed practical nursing practice for an LPN, who is educationally prepared and currently clinically competent to perform dynamic endocrine testing under the onsite supervision of a physician, APRN or registered nurse in accordance with 201 KAR 20:490 licensed practical nurse intravenous therapy scope of practice.
 - II. There should be documented evidence of the LPN's educational preparation and current clinical competence.
 - III. The LPN would be expected to follow written policy and procedures and evidence-based protocols agreed upon by the medical and nursing staff and formally adopted by the facility or organization.
- G. Klonopin[™] (clonazepam) wafers as issued December 2017:
 - I. It is within the scope of the practice of registered nurses to delegate the medication administration of Klonopin (clonazepam) wafers for seizure management to unlicensed assistive personnel.
- H. Administration of radiopharmaceuticals RN scope of practice as issued June 2017:
 - The patient education, handling, preparation, and administration by various routes (intravenous, inhalation, oral, intracavity, intrathecal, subcutaneous, and intradermal) of radiopharmaceuticals is within the scope of registered nursing practice for the registered nurse who is educationally prepared and currently clinically competent.
 - II. The registered nurse shall have documented evidence of completion of continuing education, which provides for clinical practice and demonstration of competency in the performance of such procedure.
 - III. The registered nurse is responsible to maintain documentation of educational preparation and for maintaining current clinical competence.
 - IV. The registered nurse would need to be aware of his/her own safety as well as that of the patient by applying knowledge of time, distance, and shielding in administering the radiopharmaceuticals.
- 5. That the following advisory opinions that were reaffirmed be incorporated into advisory opinion statements:
 - A. Bowel and bladder program care originally issued October 2018:
 - The advisory opinion on bowel and bladder program care be incorporated within advisory opinion statement (AOS) #11 insertion and removal of nasogastric tubes and reinsertion of percutaneous endoscopic gastrostomy (peg).
 - B. Paracentesis originally issued February 2019:
 - I. The advisory opinion on paracentesis be incorporated within advisory opinion statement (AOS) #11 insertion and removal of nasogastric tubes and reinsertion of percutaneous endoscopic gastrostomy (peg).
 - C. Thoracentesis originally issued June 2019:
 - I. The advisory opinion on thoracentesis be incorporated within advisory opinion statement (AOS) #29 cardiopulmonary/respiratory nursing practice.

- D. Therapeutic phlebotomy, RN nursing practice originally issued June 2016:
 - I. The advisory opinion on therapeutic phlebotomy be incorporated within advisory opinion statement (AOS) #25 placement of central and arterial lines, and arterial blood sampling.
- E. Gastric band adjustment, RN and LPN scope of practice originally issued October and December 2014:
 - The advisory opinions on gastric band adjustment, RN and LPN scope of practice be incorporated within advisory opinion statement (AOS) #11 insertion and removal of nasogastric tubes and reinsertion of percutaneous endoscopic gastrostomy (peg).
- F. Dynamic endocrine testing, LPN scope of practice originally issued April 2015:
 - I. The advisory opinion on dynamic endocrine testing be incorporated within advisory opinion statement (AOS) #16 roles of nurses in the administration of medications via various routes.
- G. Administration of radiopharmaceuticals RN scope of practice originally issued June 2017:
 - I. The advisory opinion on the administration of radiopharmaceuticals, RN scope of practice, be incorporated within advisory opinion statement (AOS) #16 roles of nurses in the administration of medications via various routes.
- 6. That the following advisory opinions previously deferred be incorporated into advisory opinion statements:
 - A. Scope of practice in the delegation and administration of Klonopin[™] (clonazepam) wafers originally issued November 2017:
 - I. It is within the scope of the practice of registered nurses to delegate the medication administration of Klonopin (clonazepam) wafers for seizure management to unlicensed assistive personnel, be reaffirmed and incorporated within advisory opinion statement (AOS) #30 school nursing, and where applicable to include reference to this opinion within appropriate corresponding advisory opinion statements.
 - B. Scope of practice of LPNs in the administration of local anesthesia to dental patients originally issued 2010:
 - The administration of local anesthesia to dental patients is within the scope of registered nursing practice for the nurse who possesses the requisite educational preparation and current clinical competency to perform the act in a safe effective manner. The nurse's practice should be consistent with the Kentucky nursing laws and established standards of practice, and be evidence based.
 - II. It is the advisory opinion of the board that the administration of local anesthesia to dental patients is not within the scope of the licensed practical nurse, be reaffirmed, and incorporated within advisory opinion statement (AOS) #16 roles of nurses in the administration of medications via various routes.
 - C. Scope of practice in the recommendation and administration of over the counter (OTC) medications originally issued April 2016:
 - I. A nurse, as an employee or volunteer of a health care delivery system, provides non-prescription medication to an individual; the nurse should do so based on an order from a physician, physician assistant, APRN, or dentist or medically approved guidelines to supply the non-prescription medication.

- II. An educationally prepared and clinically competent nurse, as an individual who is acting outside a health delivery system, may choose to recommend or administer a non-prescription drug (in a pre-labeled, pre-packaged form) to a person whose condition warrants it based on nursing assessment; be reaffirmed, and incorporated within advisory opinion statement (AOS) #16 roles of nurses in the administration of medications via various routes.
- 7. That the KBN comparison chart of RN/LPN practice, as submitted, be approved; and advisory opinion statement (AOS) #27 components of LPN practice, as revised, be approved.
- 8. That the proposed changes to 201 KAR 20:490 be approved.

In this fiscal year, the agency had to utilize reserve funds from prior years to offset the difference of \$271,303 in revenues and expenditures.

There were changes to the KBN's fee schedule in 2022. The dialysis technician fees for the initial program, renewal and reinstatement fees were increased. This is reflected in the current provided fee schedule.




Not all pre-licensure programs submit annual reports. Programs in developmental status will not have data to report. Programs that are in initial






Program of Nursing Admissions: New Enrollees in RN & PN Programs FY 16-17 to FY 20-21





Continuing Education Audit

The CE/Competency earning period occurs from November 1 through October 31. To ensure compliance with CE requirements, the KBN performs an annual audit of nurse licensees beginning in February of the following year. Nurses are randomly selected.

The KBN partnered with CE Broker as the official CE tracking system. CE Broker is offered to licensees and the KBN at no cost. This tool allows nurses to upload CE documents into their CE Broker account to provide proof of completion of their CE requirements and to track continuing education. CE Broker was first used during the 2020 CE Audit conducted in 2021 for nurses selected for the audit and was made available as an optional program for electronic maintenance of CE records to all nurse licensees. To ensure compliance with CE requirements, the KBN performs an annual audit of nurse licensees beginning in February of the following year. Nurses are randomly selected.

KBN received seven hundred and ninety-eight (798) responses to the audit, a ninety-five percent (95%) response rate.

Non-Compliant Individuals

A total of one hundred and forty-eight (148) nurses who submitted documents for the 2021 CE audit were deemed to be non-compliant for the November 1, 2020 – October 31, 2021 earning period.

Thirty-Nine (39) Nurse selected for the audit failed to respond to requests for submission of proof of completion of continuing competency requirements.

Non-compliant individuals were referred to the Investigation Branch.

Amended KBN Regulations for FY 2022

201 KAR 20:057 – Scope and Standards of Practice of Advanced Practice Registered Nurses This amendment to the administrative regulation went into effect on November 23, 2021. It made the following changes to the regulation:

- Removed references to KRS 314.196 (which was repealed on June 29, 2021);
- Specified a 30-day grace period for securing a CAPA-NS agreement when the APRNs previous CAPA-NS agreement ends unexpectedly for reasons outside the APRN's control;
- Premised the duty to secure KASPER master account registration on the acquisition of DEA registration, in conformity with KRS 314.042(10)(k) and KRS 218A.202(2);
- Required that submission of the KASPER master account registration occur via the online APRN Update portal; and
- Provided the URL where material incorporated by reference is located.

201 KAR 20:070E - Licensure by Examination

This emergency regulation went into effect on April 6, 2022. The amendments to this regulation affected miscellaneous provisions and was responsive to issues that came up during the legislative session around Senate Bill (SB) 10. There amendments primarily provide that graduates of nursing programs may take two attempts to pass the National Council Licensure Examination (NCLEX) before their provisional license is voided. However, it limits provisional licenses to be valid to a period of six months. The amendments also incorporate recent educational requirements under 201 KAR 20:215, and expand requirements for graduates of foreign programs of nursing to include passing an English proficiency exam under 201 KAR 20:480 before they are issued a provisional license. The revised ordinary version of the regulation is still making its way through the legislative process.

201 KAR 20:215 - Continuing Competency Requirements

The changes to this administrative regulation went into effect on January 13, 2022. They do the following:

- Clarify the separate pharmacology training requirement that apply to three categories of APRN licensees:
 - Those with a DEA X registration, which permits the prescribing of medication assisted therapies to opioid use disorder patients;
 - o Those who hold a CAPA-CS agreement, but not a DEA X registration; and
 - Those who hold neither a DEA X registration nor a CAPA-CS agreement.

- Add two new CE requirements that all RNs, LPNs and APRNs are required to satisfy once: suicide prevention (2 hours), and implicit bias (1.5 hours); Nurses who hold an active license on July 1, 2022 must satisfy the suicide prevention and implicit bias training requirements within one year, and those licensed after July 1, 2022 must satisfy the requirements within three years of licensure;
- Incorporate a preexisting domestic violence CE requirement into the regulation;
- Require submission of CE records via CE Broker, and allows requests for such records to be sent to nurses via email;
- Shorten the response time to a notice of noncompliance regarding CE's from 30 days to 10 business days; and
- Incorporates and modifies forms.

201 KAR 20:260E – Organization and Administration Standards for Prelicensure Registered Nurse or Practical Nurse Programs of Nursing.

This emergency regulation amendment went into effect on January 11, 2022. It was filed in response to Executive Order 2021-913. It requires that the Board approve within 30 days requests to increase enrollment after the program of nursing demonstrates that it has the resources to support the enrollment increase. In response to Senate Bill (SB) 10, the regulation was amended and refiled on May 5, 2022 to reconcile inconsistencies between it and the bill. The revised ordinary version of the regulation is still making its way through the promulgation process.

201 KAR 20:320 – Standards for Curriculum of Prelicensure Registered Nurse and Practical Nurse Programs

The changes to this administrative regulation went into effect on January 13, 2022. The changes:

- Clarify how and when external examinations may be used by a program of nursing, and they identify domestic violence, suicide prevention, and implicit bias as required curriculum for all Kentucky based programs of pre-licensure RN and LPN education; and
- Permit and define external examinations and their application in nursing education.

201 KAR 20:471 – Repealed 201 KAR 020:470

201 KAR 20:472 – Initial Approval for Dialysis Technician Training Programs

201 KAR 20:474 – Continuing Approval and Periodic Evaluation of Dialysis Technician Training Programs 201 KAR 20:476 – Dialysis Technician Credentialing Requirements for Initial Credentialing 201 KAR 20:478 – Dialysis Technician Scope of Practice, Discipline, and Miscellaneous Requirements The above new regulations went into effect on March 10, 2022. Regulation 201 KAR 20:471 repealed 201 KAR 20:470, and 201 KAR 20:472-8 replaced and expanded it.

201 KAR 20:480E – Licensure of Graduates of Foreign Nursing Schools

The emergency version went into effect on February 2, 2022. The amendment removed the visa screen for credentialing. In response to Senate Bill (SB) 10, the regulation was amended to reinstate visa screens as a method of credentialing. The ordinary version of the regulation is still making its way through the legislative process.

201 KAR 20:506 – Nurse Licensure Compact

The amendments went into effect on July 21, 2021. The material incorporated by was modified regarding changes to The Interstate Commission of Nurse Licensure Compact Administrators, Final Rules as of January 1, 2021.

Emergency regulation revisions per SB150 (2020RS) that are no longer effective

Regulations were modified temporarily to provide a path to licensure while fingerprint-driven criminal background checks and scheduling of the NCLEX were delayed due to social distancing requirements. Also, continuing competency requirements for reinstatement applicants were suspended. On March 5, 2021, all emergency modifications related to fingerprint-driven criminal background checks were rescinded in light of the implementation of IdentoGO fingerprint scanning across the Commonwealth, and the renewed availability of the NCLEX. Continuing Education requirements for reinstatement applicants resumed their effectiveness on the same date.

Senate Bill (SB) 10

Was an SB 10 AN ACT relating to nursing and declaring an emergency due to the Nursing shortage. It was filed on an emergency basis and went into effect on April 7, 2022. SB 10 amends Kentucky Revised Statutes Chapter 314 to do the following:


- Establish rules for registered nurses and licensed practical nurses from another state who want to practice in Kentucky, but exempts nurses licensed in a nursing compact member state;
- Direct the Board of Nursing to establish temporary work permit requirements for foreign nursing school graduates who are pursuing licensure by endorsement
- Issue a license by endorsement to international applicants who:
 - Graduated nursing school,
 - Passed the NCLEX examination, and
 - Received credentialing from the Commission on Graduates of Foreign Nursing Schools International, Inc. or another organization recognized by the board;
- Allow nurses in good standing in another state to hold a temporary work permit in Kentucky;
- Prohibit the board from restricting nursing school or nursing program student enrollment, unless the school or program has at least an average 80% pass rate for the NCLEX over the previous three years;
- Describe nursing education levels needed to teach at various types of nursing programs;
- Limit nursing board members to three consecutive terms;
- Add a certified registered nurse anesthetist to board membership;
- Make board appointments subject to confirmation by the Senate; and
- Require board appointments to include two members from each congressional district and limits the number of nurse educators to six.



Board Cases


KBN received 1,723 new disciplinary complaints, requests for reinstatement, and requests for voluntary surrender of the license during FY 2021-2022. Of the 1,469 cases, 631 were licensee/applicants with a conviction or disciplinary action in another state.

There were 2,238 cases resolved during FY 2021-2022, including those that were unsubstantiated without action, and 22 cases that were resolved by admission to the KARE Program.

Kentucky Alternative Recovery Effort (KARE) for Nurses Program


The Kentucky Alternative Recovery Effort (KARE) for Nurses Program was developed and is offered by the Kentucky Board of Nursing to identify nurses whose abilities to provide nursing care are compromised by a Substance Use Disorder with the goal of assisting these nurses so that they can return to competent and safe practice. The foundation of the KARE for Nurses Program is that substance use disorders are treatable and that the nurse's recovery and return to competent nursing practice is in the best interest of the nurse and public health.


Candidates for the KARE for Nurses Program must be a Licensed Practical Nurse, Registered Nurse, or Advanced Practice Registered Nurse licensed in the Commonwealth of Kentucky, or an applicant for such licensure. In order to be eligible for admission into or continued participation in the KARE Program, candidates and participants must agree to the terms set forth in the KARE for Nurses Program Agreement.





Compliance Monitoring

The compliance staff monitors nurses on limitation/probation via an Agreed Order or by Decision. This includes Registered Nurses, Advanced Practice Registered Nurses and Licensed Practical Nurses, as well as dialysis technicians. The compliance staff also monitors nurses with Reprimands on their license, some of which are participating in the drug screening program. The Branch is also responsible for issuing Notice of Intents for suspension or denial of reinstatement after violation of the terms of any agreement. The Branch works with nurses that request reinstatement after disciplinary action and offers resolution. The staff prepares settlement agreements after violation of terms of any agreement with the Board and also reviews files to clear nurses from monitoring to assure compliance with all terms and the nurse licensure compact rules.




<u>51 posts between July 1, 2021 – June 30,</u> <u>2022</u>
