



### **Advanced Practice Registered Nurse Investigator (Non-Merit)**

The Kentucky Board of Nursing, Compliance Branch in Louisville (Jefferson County) has an opening for a non-merit Advanced Practice Registered Nurse Investigator.

#### **DUTIES AND RESPONSIBILITIES:**

- Investigates alleged nursing practice violations and monitors compliance with Board Orders and Agreements for Advanced Practice Registered Nurses (APRN), Nurse Practitioners (NP), Clinical Nurse Specialists (CNS), Certified Nurse-Midwives (CNM), and Certified Registered Nurse Anesthetists (CRNA), and other licensees.
- Monitors compliance with Kentucky Alternative Recovery Effort (KARE) program agreements. Tracks compliance efforts, prepares reports, and maintains accurate and confidential records.
- Conducts interviews and meetings with licensees and applicants. Presents information to Board Members for review.
- Reviews Kentucky All Schedule Prescription Electronic Reporting (KASPER) reports for compliance with regulatory standards and monitoring agreements.
- Reviews patient medical records, prescriber reports, subpoenaed records, and other materials pertaining to investigations and case monitoring.
- Prepares non-compliance letters, Notice of Intent to Suspend/Deny Reinstatement documents and Agreed Orders for licensees in violation of monitoring terms.
- Provides testimony at Administrative Hearings.
- Performs other duties as assigned.

The ideal candidate will have the ability to communicate effectively, maintain integrity, manage time efficiently, adapt to change and be self-motivated. Experience working with Substance Use Disorders is preferred.
